1	AN ACT
2	To enact R.S. 11:163.2, relative to the Municipal Employees' Retirement System; to provide
3	for credit for involuntary furlough and leave without pay; to provide with respect to
4	the purchase of service and salary credit lost as a result of COVID-related
5	involuntary furlough or leave for certain employees; to provide with respect to
6	payment for service purchased; to provide for limitations; to provide for
7	implementation; to provide for an effective date; and to provide for related matters.
8	Notice of intention to introduce this Act has been published.
9	Be it enacted by the Legislature of Louisiana:
10	Section 1. R.S. 11:163.2 is hereby enacted to read as follows:
11	§163.2. Involuntary furlough; service and salary credit; credit for leave
12	without pay
13	A.(1) Any member of the Municipal Employees' Retirement System of
14	Louisiana who, due to the COVID-19 pandemic, was involuntarily furloughed
15	without pay due to a reduction-in-force of his employer or was involuntarily
16	furloughed or placed on leave without pay may purchase service and salary
17	credit for each day of service during the period beginning on April 1, 2020, and
18	ending on November 30, 2020, that he was furloughed or on such leave if such

1	service was not credited to his account, subject to the limitations contained in
2	Subsection B of this Section.
3	(2) A member who purchases service and salary credit pursuant to this
4	Section shall pay to the system or to his employer the employee and employer
5	contributions which would have been remitted to the system by his employer if
6	not for the involuntary furlough or leave without pay. Such contributions, if
7	paid to the employer, shall be remitted by the employer to the system. The
8	member shall remit the contributions no later than December 31, 2021.
9	B. Any service and salary credit purchased pursuant to this Section shall
10	be subject to the following conditions and limitations:
11	(1) There shall be no duplication of service credit.
12	(2) The employer shall certify the loss of service credit was due to the
13	COVID-19 pandemic.
14	(3) The purchased service and salary credit may not be used for the
15	purpose of meeting the minimum service requirements for disability retirement.
16	(4) Compensation on which the required contributions for purchase of
17	service and salary credit are based shall be the rate of compensation in effect for
18	the last full pay period ending on or before the date the member was furloughed
19	or placed on leave without pay.
20	(5) The right to purchase service and salary credit pursuant to this
21	Section shall not apply to routine personnel actions or separations which are not
22	the direct result of the COVID-19 pandemic.
23	(6) Any dispute arising under the limitations of this Subsection shall be
24	resolved in the sole and exclusive discretion of the board of trustees of the
25	retirement system.
26	C. The board of trustees may adopt rules to implement the provisions of
27	this Section.
28	Section 2. This Act shall become effective upon signature by the governor or, if not
29	signed by the governor, upon expiration of the time for bills to become law without signature
30	by the governor, as provided by Article III, Section 18 of the Constitution of Louisiana. If
