2	To amend and reenact R.S. 30:2418(H)(1) and to enact R.S. 30:2418.1 and 2418.2, relative
3	to the waste tire program in the Department of Environmental Quality; to authorize
4	the establishment of standards, requirements, and permitting procedures; to provide
5	for waste tire generators; to authorize the promulgation of rules, regulations, and
6	guidelines; to require certain generators of waste tires to obtain generator
7	identification numbers; to require certain transporters to obtain a certificate; to
8	provide for criminal penalties; and to provide for related matters.
9	Be it enacted by the Legislature of Louisiana:
10	Section 1. R.S. 30:2418(H)(1) is hereby amended and reenacted and R.S. 30:2418.1
11	and 2418.2 are hereby enacted to read as follows:
12	§2418. Waste tires

14	H. The secretary shall promulgate rules, regulations, and guidelines for the
15	administration and enforcement of the waste tire program provided for in this
16	Chapter, which shall be subject to legislative review and approval by the Senate
17	Committee on Environmental Quality and the House Committee on Natural
18	Resources and Environment. The rules, regulations, and guidelines shall provide for
19	but not be limited to:
20	(1) Establishing standards, requirements, and permitting procedures for waste
21	tire transporters, collection sites, generators, and processors. Requirements The
22	requirements for waste tire transporters, collection sites, and processors shall
23	include proof of commercial liability insurance in a sufficient amount and other
24	evidence of financial responsibility as determined by the secretary. For waste tire

1	transporters, financial responsibility shall include a surety bond in a minimum
2	amount of ten thousand dollars, as determined by the secretary.
