BESE: (Constitutional Amendment) Eliminates the gubernatorial appointment of three members of the State Board of Elementary and Secondary Education, providing for an all-elected membership and reducing the membership to eight

A JOINT RESOLUTION

2	Proposing to amend Article VIII, Section 3(B) and (C) of the Constitution of Louisiana, to
3	provide relative to the membership of the State Board of Elementary and Secondary
4	Education; to eliminate the gubernatorial appointment of three members; to reduce
5	the membership from eleven members to eight members; to provide for submission
6	of the proposed amendment to the electors; and to provide for related matters.
7	Section 1. Be it resolved by the Legislature of Louisiana, two-thirds of the members
8	elected to each house concurring, that there shall be submitted to the electors of the state of
9	Louisiana, for their approval or rejection in the manner provided by law, a proposal to
10	amend Article VIII, Section 3(B) and (C) of the Constitution of Louisiana, to read as
11	follows:
12	§3. State Board of Elementary and Secondary Education
13	Section 3.
14	* * *
15	(B)(1) Membership; Terms. The board shall consist of eleven eight
16	members, eight of whom who shall be elected from single-member districts, which
17	shall be determined as provided by law, and three of whom shall be appointed by the
18	governor from the state at large, with consent of the Senate. Members shall serve
19	terms of four years, which shall be concurrent with the term of the governor.

CODING: Words in struck through type are deletions from existing law; words <u>underscored</u> are additions.

1	(2) No person who has served as a member of the board for more than two
2	and one-half terms in three consecutive terms shall be elected or appointed to the
3	board for the succeeding term. This Subparagraph shall not apply to any person
4	elected or appointed to the board prior to the effective date of this Subparagraph,
5	December 8, 2008, except that it shall apply to any term of service of any such
6	person that begins after such date.
7	(C) Vacancy. A vacancy in the office of an elected <u>a</u> member, if the
8	remaining portion of the term is more than one year, shall be filled for the remainder
9	of the term by election, as provided by law. Other vacancies shall be filled for the
10	remainder of the term by appointment by the governor.
11	Section 2. Be it further resolved that this proposed amendment shall be submitted
12	to the electors of the state of Louisiana at the statewide election to be held on November 8,
13	2022.
14	Section 3. Be it further resolved that if the proposed amendment contained in this
15	Joint Resolution is ratified by the electors of the state, the provisions of the amendment shall
16	become effective at noon on January 8, 2024.
17	Section 4. Be it further resolved that on the official ballot to be used at the election,
18	there shall be printed a proposition, upon which the electors of the state shall be permitted
19	to vote YES or NO, to amend the Constitution of Louisiana, which proposition shall read as
20	follows:
21	Do you support an amendment to provide for the election of all members of
22	the State Board of Elementary and Secondary Education by removing the
23	governor's authority to appoint three members? (Effective at noon on
24	January 8, 2024.) (Amends Article VIII, Section 3(B) and (C))

Abstract: Provides for an all-elected membership of the State Board of Elementary and Secondary Education by removing the governor's appointment of three members (reducing the membership <u>from</u> 11 <u>to</u> eight).

<u>Present constitution</u> creates the State Board of Elementary and Secondary Education (BESE) to supervise and control the public elementary and secondary schools and special schools under its jurisdiction. <u>Proposed constitutional amendment</u> retains <u>present constitution</u>.

<u>Present constitution</u> provides that eight members are elected to BESE from single-member districts and three are appointed by the governor from the state at large. <u>Proposed constitutional amendment</u> reduces BESE membership <u>from</u> 11 <u>to</u> eight by removing the gubernatorial appointment of three at-large members.

Present constitution provides the following relative to terms:

- (1) Members shall serve terms of four years, which shall be concurrent with the term of the governor.
- (2) No person who has served as a member of the board for more than two and one-half terms in three consecutive terms shall serve for the succeeding term.

Proposed constitutional amendment retains present constitution.

<u>Present constitution</u> provides following for the filling of vacancies of elected members of BESE:

- (1) If more than one year is left in the term at the time the position becomes vacant, a special election is required to fill the position.
- (2) If less than one year is left in the term at the time the position becomes vacant, the governor is required to appoint a replacement for the remainder of the term.

<u>Proposed constitutional amendment</u> retains <u>present constitution</u>.

Provides for submission of the proposed amendment to the voters at the statewide election to be held on November 8, 2022.

Effective at noon on January 8, 2024.
