# VETERANS: Provides relative to the Louisiana National Guard death and disability benefits

1	AN ACT
2	To amend and reenact R.S. 29:26.1(B)(6)-(11), (C)(3)(b), (D)(1), and (E)(2) and to enact
3	R.S. 29:26.1(B)(12), relative to the Louisiana National Guard; to provide for
4	definitions; to provide for disability claims and death benefits; to provide for
5	availability of disability and death benefits; to provide for subsequent disabilities;
6	and to provide for related matters.
7	Be it enacted by the Legislature of Louisiana:
8	Section 1. R.S. 29:26.1(B)(6)-(11), (C)(3)(b), (D)(1), and (E)(2) are hereby amended
9	and reenacted and R.S. 29:26.1(B)(12) is hereby enacted to read as follows:
10	§26.1. National Guard death and disability benefits
11	* * *
12	B. Definitions. As used in this Section, the following terms shall have the
13	following meanings unless a different meaning is clearly required by context:
14	* * *
15	(6) "Guardsman or guardsmen" means <u>a person who was</u> an officer or
16	enlisted member of the Louisiana National Guard and who was discharged or
17	released from all periods of federal and state service under honorable or general
18	under honorable conditions.

1	(7) <u>"Initial rating decision" means the first disability rating decision by the</u>
2	United States Department of Veterans Affairs on the guardsman's first-filed claim
3	for service-connection of injuries.
4	(8) "LANG" means the Louisiana National Guard.
5	(8)(9) "Period of activation" means service during any declared national
6	emergency or contingency operations as defined by 10 U.S.C. 101(a)(13), or during
7	any state emergency declared by the governor of the state of Louisiana, within any
8	of the following:
9	(a) That period, subsequent to September 11, 2001, for which the governor
10	of the state of Louisiana orders a guardsman into state active service pursuant to R.S.
11	29:7.
12	(b) That period, subsequent to September 11, 2001, for which the president
13	of the United States orders a guardsman into active military duty, pursuant to 32
14	U.S.C. 502(f)(1).
15	(c) That period, subsequent to September 11, 2001, for which the president
16	of the United States orders a guardsman to federal active duty pursuant to 10 U.S.C.
17	12301, 12302, or 12303.
18	(9)(10) "Qualifying claim" means an application for benefits by a guardsman
19	or beneficiary for a qualifying death or disability incurred during a period of
20	activation in the line of duty, and meeting the documentation requirements of this
21	Section.
22	(10)(11) "Qualifying disability" means a one hundred percent permanent
23	total disability rating, or a permanent and total unemployability disability rating as
24	determined by the United States Department of Veterans Affairs and certified by the
25	Louisiana secretary of veterans affairs in a final adjudication of the initial rating
26	decision or as determined or certified by the proper state entity that adjudicates such
27	claims for guardsmen in accordance with the workers' compensation law of this state.
28	A qualifying disability shall be certified by the Louisiana secretary of veterans
29	affairs or his designee. As provided for in this Paragraph, the initial rating decision

1	shall not apply to a United States Department of Veterans Affairs rating decision
2	which predates service in the Louisiana National Guard.
3	(11)(12) "Qualifying subsequent examination disability" means after initial
4	examination or rating, the guardsman's initial injuries progressed or worsened the
5	initial rating decision, the combination of service-connected ratings of all injuries the
6	guardsman incurred during a period of activation, as well as any other injuries
7	service-connected on a secondary basis to those injuries incurred during a period of
8	activation, reaches a causing the guardsman to receive one hundred percent
9	permanent total disability rating, or a permanent and total unemployability disability
10	rating as determined by the United States Department of Veterans Affairs.

13	(3) Each claim for a disability benefit shall include all of the following
14	documentation:

16	(b) A disability The guardsman's initial rating decision and any subsequent
17	rating decisions reached by the United States Department of Veterans Affairs and
18	certified by the Louisiana secretary of veterans affairs or his designee.

20	D. Benefits available. (1) During periods of activation, subsequent to
21	September 11, 2001, of a guardsman ordered by the governor or by the president of
22	the United States, benefits in a lump-sum amount of two hundred fifty thousand
23	dollars for a qualifying death, one hundred thousand dollars for a qualifying
24	disability, and fifty thousand dollars for qualifying subsequent examination disability
25	shall be paid by the state to a guardsman or his beneficiary, when such death or
26	disability occurs during a period of activation in the line of duty as required by this
27	Section. Such benefits shall be paid only when funds are available, having been
28	appropriated for the purpose.

4	determined by the United States Department of Veterans Affairs or by the proper
5	state entity that adjudicates such claims for guardsmen in accordance with the
6	workers' compensation law of this state and certified by the secretary of the
7	Louisiana Department of Veterans Affairs or his designee.

Abstract: Modifies the criteria for disability benefits available to Louisiana National Guardsmen.

Present law provides for definitions.

<u>Proposed law</u> retains <u>present law</u> and modifies the definitions of "guardsman or guardsmen", "period of activation", and "qualifying subsequent examination". Creates the definition for "initial rating decision" and changes the term "qualifying subsequent examination" <u>to</u> "qualifying disability".

<u>Present law</u> provides that all death benefits claims provided under <u>present law</u> shall be submitted to the La. National Guard and that all claims for disability benefits shall be submitted to the La. Dept. of Veterans Affairs.

<u>Present law</u> provides that a disability rating decision reached by the United States Dept. of Veterans Affairs and certified by the Louisiana secretary of veterans affairs or his designee shall be included in the documentation for a disability benefit claim.

<u>Proposed law</u> retains <u>present law</u> and provides that both a guardsman's initial rating decision and any subsequent rating decision shall be included in the documentation for a disability benefit claim.

<u>Present law</u> provides for during periods of activation, subsequent to Sept. 11, 2001, of a guardsman ordered by the governor or by the president of the United States, benefits in a lump-sum amount of \$250,000 for a qualifying death, \$100,000 for a qualifying disability, and \$50,000 for qualifying subsequent examination shall be paid by the state to a guardsman or his beneficiary, when such death or disability occurs during a period of activation in the line of duty as required by <u>present law</u>. Provides that such benefits shall be paid only when funds are available, having been appropriated for the purpose.

<u>Proposed law</u> retains <u>present law</u> and provides that a guardsman or his beneficiary shall be paid \$50,000 in benefits for a subsequent disability instead of a subsequent examination.

<u>Present law</u> provides that a qualifying disability shall be determined by the United States Dept. of Veterans Affairs or by the proper state entity that adjudicates such claims for guardsmen in accordance with state workers' compensation law and certified by the secretary of the Louisiana Dept. of Veterans Affairs or his designee.

<u>Proposed law</u> retains <u>present</u> law and gives the United States Dept. of Veterans Affairs or the proper adjudicatory state entity the additional option of determining what is a qualifying subsequent disability.
