SCHOOLS: Provides relative to public school calendar requirements

2	To enact R.S. 17:154.1(C) and 1945.3 and to repeal Subpart H of Part III of Chapter 1 of
3	Title 17, comprised of R.S. 17:341 through 348; relative to public school calendars,
4	to require public school governing authorities to determine school calendars; to
5	provide relative to the powers and duties of the State Board of Elementary and
6	Secondary Education and the state Department of Education with respect to school
7	calendars; and to provide for related matters.
8	Be it enacted by the Legislature of Louisiana:
9	Section 1. R.S. 17:154.1(C) and 1945.3 are hereby enacted to read as follows:
10	§154.1. Length of school day and year; requirements
11	* * *
12	C. Each public school governing authority shall determine the school-year
13	calendar for the schools under its jurisdiction. Neither the State Board of Elementary
14	and Secondary Education nor the state Department of Education shall determine or
15	require approval of a calendar for any city, parish, or other local public school board
16	in the state.

Abstract: Requires public school governing authorities to determine school-year calendars.

<u>Present law</u> authorizes a public school governing authority to adjust the number of instructional minutes and instructional days for the schools under their jurisdictions, provided the total number of instructional minutes per year is no less than the minimum number of instructional minutes per day (360) multiplied by the minimum number of instructional days (177) required by <u>present law</u>. <u>Proposed law</u> retains <u>present law</u> and further requires public school governing authorities to determine school-year calendars for the schools under their jurisdictions.

<u>Present law</u> authorizes public school governing authorities to have schools operating under year-round calendars, subject to approval by the State Bd. of Elementary and Secondary Education (BESE). <u>Proposed law</u> repeals <u>present law</u>.

<u>Proposed law</u> prohibits BESE and the state Dept. of Education from requiring approval of school-year calendars and from setting school-year calendars for public schools.
