REGISTRARS OF VOTERS: Provides relative to the salaries of registrars of voters and their chief deputies and confidential assistants


#### Abstract

AN ACT

To amend and reenact R.S. 18:55(A)(2) and (4)(a) and 59(B)(2) and (4)(a) and (C)(2) and (4)(a), relative to the offices of parish registrars of voters; to provide relative to compensation of registrars and their chief deputies and confidential assistants; to provide for an effective date; and to provide for related matters.


Be it enacted by the Legislature of Louisiana:
Section 1. R.S. 18:55(A)(2) and (4)(a) and 59(B)(2) and (4)(a) and (C)(2) and (4)(a) are hereby amended and reenacted to read as follows:
§55. Compensation of registrar of voters; amount and manner of payment; reduction during tenure prohibited; prohibited increase

However, achief deputy whose salary is less thanstep one of the applieable population range shall reeeive an anntual salary inerease of four thousand five hundred dollars until that amount would eause his salary to exeeed step one. At that time, he shall reeeive a salary inerease to the amount of the nearest step whieh will provide an inerease of not less than three hundred dollars.

#### Abstract

Provides for additional compensation for registrars of voters and their chief deputies and confidential assistants who have more than 12 years of experience.

Present law provides pay schedules for registrars of voters and their chief deputies and confidential assistants. Compensation varies based on the population of the parish and the years of experience of the individual. Years of experience are expressed as steps on the salary schedule.

Present law provides that each registrar, chief deputy, and confidential assistant shall receive an annual salary increase to the next step on July first until his annual salary equals the highest step of the appropriate population range. Present law also provides that such step increases in salary shall be given upon a finding of "excellent" on a merit evaluation.

Present law, for all three positions, provides that the highest step on the salary schedule is step 12.

Proposed law adds salaries for eight more steps to the salary schedules. Retains present law salaries for the first 12 steps.

Present law provides for an adjustment to salaries that are lower than the schedule amount for the first step. Proposed law removes this provision.
