Proposed legislation provides additions to the list of topics on which public schools must provide information as part of required instruction on the Founding Principles of the United States of America. Requires the provision of age and grade appropriate instruction in civics to public school students in grades Kindergarten through 8. Provides for the required founding principals and materials to be included in that instruction. Repeals existing statute requiring study of the Declaration of Independence in elementary schools and the Federalist Papers in high schools. Provides for age- and grade-appropriate instruction in comparative discussion of political ideologies, such as communism and totalitarianism, that conflict with the ideology of the United States in grades five through eight.
