SUNSET LAW: Re-creates the Department of Economic Development

1 AN ACT 2 To amend and reenact R.S. 49:191(1) and to repeal R.S. 49:191(10)(e), relative to the 3 Department of Economic Development, including provisions to provide for the 4 re-creation of the Department of Economic Development and the statutory entities 5 made a part of the department by law; to provide for the effective termination date 6 for all statutory authority for the existence of such statutory entities; and to provide 7 for related matters. 8 Be it enacted by the Legislature of Louisiana: 9 Section 1. Pursuant to R.S. 49:193, the Department of Economic Development and 10 the statutory entities made a part of the department by law shall be re-created effective June 11 30, 2022, and all statutory authority therefor is continued in accordance with the provisions 12 of Part XII of Chapter 1 of Title 49 of the Louisiana Revised Statutes of 1950. 13 Section 2. All statutory authority for the existence of the Department of Economic 14 Development and the statutory entities made a part of the department as re-created by 15 Section 1 of this Act shall cease as of July 1, 2027, pursuant to R.S. 49:191. However, the 16 Department of Economic Development may be re-created prior to such date in accordance 17 with the provisions of Part XII of Chapter 1 of Title 49 of the Louisiana Revised Statutes of 18 1950. 19 Section 3. The provisions of R.S. 49:193 are hereby superseded to the extent that 20 those provisions are in conflict with the provisions of this Act.

5	legislature, the statutory entities set forth in this Section shall begin to terminate their
6	operations on July first of each of the following years, and all legislative authority
7	for the existence of any statutory entity, as defined in R.S. 49:190, shall cease as of
8	July first of the following year, which shall be the termination date:
9	(1) July 1, 2006 <u>2026</u> :
10	(a) The Department of Economic Development and all statutory entities
11	made a part of the department by law.

13	Section 5. R.S. 49:191(10)(e) is hereby repealed in its entirety.
14	Section 6. This Act shall become effective on June 30, 2022; if vetoed by the
15	governor and subsequently approved by the legislature, this Act shall become effective on
16	June 30, 2022, or on the day following such approval by the legislature, whichever is later.

Abstract: Re-creates the Department of Economic Development.

<u>Present law</u> (Sunset) provides that the Dept. of Economic Development and all the statutory entities made a part of that department by law shall begin to terminate their operations on July 1, 2022, and that all legislative authority for such entities shall cease as of July 1, 2023, unless the legislature enacts a bill authorizing the re-creation of the department and its statutory entities prior thereto.

<u>Proposed law</u> provides for the general re-creation of the Dept. of Economic Development and its statutory entities, effective June 30, 2022, in accordance with the sunset law.

<u>Proposed law</u> supersedes the provisions of the sunset law which set out the procedure for review and re-creation and which require a separate bill to re-create each statutory entity within the department along with additional provisions.

<u>Proposed law</u> makes July 1, 2027, the new termination date and termination would begin July 1, 2026, unless the department is again re-created.
