HEARING AID DEALERS. Provides relative to the Louisiana Board for Hearing Aid Dealers. (8/1/22)

1 AN ACT

2 To amend and reenact R.S. 37:2441, relative to the Louisiana Board for Hearing Aid  
3 Dealers; to provide for registration and licensure; to provide legislative intent; and  
4 to provide for related matters.

5 Be it enacted by the Legislature of Louisiana:

6 Section 1. R.S. 37:2441 is hereby amended and reenacted to read as follows:

7 §2441. Registration and licensing required

8 ~~In order to protect the public welfare, aid the Department of Revenue in~~  
9 ~~collecting sales taxes on labor and on retail prices of hearing aids, and material used~~  
10 ~~in the service and maintenance of hearing aids; to protect privately owned property~~  
11 ~~and to provide an adequate supply of licensed dealers throughout the state by the~~  
12 ~~establishment of the apprenticeship training program by the board; any person~~  
13 ~~rendering or offering to render services for the sale, maintenance, and repair of any~~  
14 ~~type of hearing aid as defined in R.S. 37:2442 shall hereafter be required to be~~  
15 ~~registered and licensed as hereinafter provided, and it shall be unlawful for any~~  
16 ~~person to engage in or offer to engage in the state hearing aid sales and repair service~~  
17 ~~as defined in R.S. 37:2442 unless duly registered and licensed in accordance with~~

1 this Chapter or as an audiologist under the provisions of Chapter 34 of Title 37 of the  
 2 Louisiana Revised Statutes of 1950; that there is hereby created a board to be known  
 3 as the Louisiana Board for Hearing Aid Dealers.

4 **A. Any person engaging in the practice of selling and fitting of any type**  
 5 **of hearing aid, as defined in R.S. 37:2442, shall be registered and licensed by the**  
 6 **Louisiana Board for Hearing Aid Dealers.**

7 **B. The provisions of this Section are enacted to:**

8 **(1) Protect the public.**

9 **(2) Aid the Department of Revenue in collecting sales taxes on labor, on**  
 10 **retail prices of hearing aids, and on material used in the repair, service, and**  
 11 **maintenance of hearing aids.**

12 **(3) Provide an adequate supply of licensed hearing aid dealers**  
 13 **throughout the state to serve as sponsors for applicants seeking temporary**  
 14 **training permits pursuant to R.S. 37:2449.**

Pope

Present law requires hearing aid dealers to be registered and licensed with the Louisiana Board for Hearing Aid Dealers if they render or offer to render services for the sale, maintenance, and repair of any type of hearing aid. Present law provides legislative intent.

Proposed law retains present law registration and licensure requirements for any person engaging in the practice of selling and fitting any type of hearing aid and provides legislative intent. Proposed law deletes present law provisions that are provided for in other present law statutes relative to hearing aid dealers.

Effective August 1, 2022.
