 Requires mayors who are authorized to conduct mayor's court or municipal court to undergo certain training. (8/1/22)

Proposed legislation requires every mayor or magistrate presiding over a mayor's court to receive training on ethics, and on judicial and legal procedures related to mayor's courts.

**EXPENDITURE EXPLANATION**

There will be no cost to the Judicial College of the Louisiana Supreme Court as a result of the proposed law. The Judicial College met on April 8, 2021 and decided to offer an annual online training course for mayors or magistrates presiding over a mayor's court.

There will be no cost for mayors' courts as the required training in the proposed law will be offered virtually by the Judicial College at no cost.

There will be no fiscal impact to the Legislative Auditor's office as a result of the proposed measure. The Auditor reports the office can provide the training utilizing existing resources.
