MTR VEHICLE/LICEN PLATES: Creates military honor specialty license plates

1	AN ACT
2	To enact R.S. 47:490.34 through 490.36, relative to military honor license plates; to provide
3	for the establishment of a military honor license plate for women veterans,
4	Commemorative Service recipients, and Military Medal Award recipients; to provide
5	for the creation, issuance, fees, distribution, and rule promulgation applicable to the
6	design of such plates; and to provide for related matters.
7	Be it enacted by the Legislature of Louisiana:
8	Section 1. R.S. 47:490.34 through 490.36 are hereby enacted to read as follows:
9	§490.34. Military honor license plates; "Woman Veteran"; "Commemorative
10	Service"; and "Military Medal Award"
11	A. The secretary of the Department of Public Safety and Corrections shall
12	establish a military honor license plate to be known as the "Woman Veteran" plate.
13	B. Upon application of a "Woman Veteran" recipient, the secretary of the
14	Department of Public Safety and Corrections shall issue a military honor license
15	plate to be used in lieu of a regular motor vehicle registration plate. The license plate
16	shall be restricted to use on passenger cars, pickup trucks, recreational vehicles,

1	motorcycles, and vans. The "Woman Veteran" plate shall include the seal of the
2	veteran's branch of service and the words "Woman Veteran".
3	C. The charge for this license plate shall be the regular motor vehicle

5	D. The secretary shall adopt rules and regulations to implement the
6	provisions of this Section, including but not limited to rules governing the transfer
7	of license plates from one vehicle to another and the disposition of such license
8	plates.

A.(1) The secretary of the Department of Public Safety and Corrections shall
establish a military honor license plate to be known as the "Military Medal Award"
plate.

1	(2) This plate shall be made available to honorably discharged recipients, as
2	certified by the Department of Veteran's Affairs, of the following medal awards:
3	(a) Navy Cross.
4	(b) Air Force Cross.
5	(c) Defense Distinguished Service Medal.
6	(d) Homeland Security Distinguished Service Medal.
7	(e) Distinguished Service Medal (Army).
8	(f) Navy Distinguished Service Medal.
9	(g) Air Force Distinguished Service Medal.
10	(h) Coast Guard Distinguished Service Medal.
11	(i) Silver Star.
12	(j) Defense Superior Service Medal.
13	(k) Legion of Merit.
14	(l) Distinguished Flying Cross.
15	(m) Air Medal.
16	(n) Soldier's Medal.
17	(o) Airman's Medal.
18	(p) Navy and Marine Corps Medal.
19	(q) Coast Guard Medal.
20	B. Upon application of a "Military Medal Award" recipient, as certified by
21	the Department of Veteran's Affairs, the secretary of the Department of Public Safety
22	and Corrections shall issue a military honor license plate to be used in lieu of a
23	regular motor vehicle registration plate. The license plate shall be restricted to use
24	on passenger cars, pickup trucks, recreational vehicles, motorcycles, and vans. The
25	military honor license plate shall be known as the "Military Medal Award" license
26	plate and shall include the name of the veteran's branch of service and the name and
27	image of the medal.
28	C. The charge for this license plate shall be the regular motor vehicle
29	registration license fee as provided for under the provisions of R.S. 47:463.

17	Section 2. The Department of Public Safety and Corrections, office of motor
18	vehicles, is hereby directed to create these military honor license plates when the applicable
19	statutory provisions are met and its system is updated to accommodate the creation of new
20	plates.

**Abstract:** Creates the "Woman Veteran", "Commemorative Service" recipient, and "Military Medal Award" recipients speciality license plates.

<u>Proposed law</u> creates the "Woman Veteran", "Commemorative Service recipient", and "Military Medal Award". Provides for the use, name, design, and specifications of the specialty plates.

<u>Proposed law</u> requires the charge for the license plates be the regular motor vehicle registration license fee as provided for in <u>present law</u>, which waives the \$3.50 handling fee for such plate.

<u>Proposed law</u> requires the "Woman Veteran" license plate include the seal of the veteran's branch of service and the words "Woman Veteran".

<u>Proposed law</u> requires the "Commemorative Service" license plate be made available to honorably discharged veterans for serving in the following conflicts:

- (1) Global War on Terrorism.
- (2) War in Iraq.
- (3) War in Afghanistan.

<u>Proposed law</u> requires the "Commemorative Service" license plate include the seal of the veteran's branch of service, the name of the conflict, and the campaign ribbon.

<u>Proposed law</u> requires the "Military Medal Award" license plate be made available to honorably discharged recipients, as certified by the Department of Veteran's Affairs, of the following medal awards:

- (1) Navy Cross.
- (2) Air Force Cross.
- (3) Defense Distinguished Service Medal.
- (4) Homeland Security Distinguished Service Medal.
- (5) Distinguished Service Medal (Army).
- (6) Navy Distinguished Service Medal.
- (7) Air Force Distinguished Service Medal.
- (8) Coast Guard Distinguished Service Medal.
- (9) Silver Star.
- (10) Defense Superior Service Medal.
- (11) Legion of Merit.
- (12) Distinguished Flying Cross.
- (13) Air Medal.
- (14) Soldier's Medal.
- (15) Airman's Medal.
- (16) Navy and Marine Corps Medal.
- (17) Coast Guard Medal.

<u>Proposed law</u> requires the "Military Medal Award" plate include the name of the veteran's branch of service and the name and image of the medal.

<u>Proposed law</u> requires the secretary of the Dept. of Public Safety and Corrections to adopt rules relative to the implementation of the military honor license plates, including the transfer of the license plate to the surviving spouse and the disposition of the military honor license plates.

<u>Proposed law</u> requires the office of motor vehicles to create the military honor plates provided for in <u>proposed law</u> when the applicable statutory provisions are met and its system is updated to accommodate new plates.

## Summary of Amendments Adopted by House

The Committee Amendments Proposed by <u>House Committee on Transportation</u>, Highways and Public Works to the original bill:

- 1. Make technical changes.
- 2. Remove the handling fee of \$3.50 that was applicable to each military honor license plate.
- 3. Remove the inclusion of the U.S. flag background on each license plate.
- 4. Require the office of motor vehicles to create the military honor plates provided for in <u>proposed law</u> when the applicable statutory provisions are met and its system is updated to accommodate new plates.

## The House Floor Amendments to the engrossed bill:

1. Add the Airman's Medal, Navy and Marine Corps Medal, and Coast Guard Medal to the list of medal awards required to be available to honorably discharged recipients for the "Military Medal Award" license plate.
