LEGIS POWERS/FUNCTIONS. Provides for remote operations of the legislature during a gubernatorially declared state of emergency. (gov sig)

1	AN ACT
2	To enact R.S. 42:17.2, relative to meetings of legislative houses and committees during a
3	gubernatorially declared state of disaster or emergency; to provide for public input;
4	to provide for an effective date; and to provide for related matters.
5	Be it enacted by the Legislature of Louisiana:
6	Section 1. R.S. 42:17.2 is hereby enacted to read as follows:
7	<u>§17.2. Exception for meetings of legislative houses and committees during a</u>
8	gubernatorially declared disaster or emergency
9	A. Notwithstanding any other provision of this Chapter to the contrary,
10	members of the legislature or legislative committee may remotely attend,
11	participate, vote, and transact business via electronic means provided:
12	(1) The governor has declared a state of emergency or disaster and the
13	nature of the emergency or disaster would cause a meeting of the legislature or
14	legislative committee conducted pursuant to the other provisions of this Chapter
15	to be detrimental to the health, safety, or welfare of the public.
16	(2) The presiding officer of the house of which he is a member certifies
17	on the notice of the meeting that the agenda of the meeting is limited to one or

1	more of the following:
2	(a) Matters that are directly related to the legislature's response to the
3	disaster or emergency and are critical to the health, safety, or welfare of the
4	public.
5	(b) Matters that if they are delayed will cause curtailment of vital public
6	services or severe economic dislocation and hardship.
7	(c) Matters that are critical to continuation of the business of the
8	legislature and that are not able to be postponed to a meeting held in
9	accordance with the other provisions of this Chapter due to a legal requirement
10	or other deadline that cannot be postponed or delayed by the legislature.
11	B. No later than twenty-four hours prior to a meeting to be conducted
12	pursuant to the provisions of this Section, the legislature or legislative
13	committee shall provide for all of the following:
14	(1) The notice and agenda for the meeting, which shall be posted on the
15	legislative website, emailed to any member of the public who requests notice of
16	the meeting, and widely distributed upon request to every known news media
17	outlet that broadcasts or publishes legislative news.
18	(2) Detailed information regarding how members of the public may
19	participate in the meeting and submit comments regarding matters on the
20	agenda, which information shall be posted on the legislative website, emailed to
21	any member of the public who requests notice of the meeting, and widely
22	distributed upon request to every known news media outlet that broadcasts or
23	publishes legislative news.
24	C. Each meeting conducted pursuant to this Section shall comply with
25	the following:
26	(1) The legislature or legislative committee shall provide a mechanism
27	to receive public comment electronically both prior to and during the meeting.
28	(2) The legislature or legislative committee shall properly identify and
29	acknowledge all public comments during the meeting and shall maintain those

1	comments in its record of the meeting.
2	(3) The presiding officer shall ensure that each person participating in
3	the meeting is properly identified.
4	(4) The presiding officer shall ensure that all parts of the meeting,
5	excluding any matter discussed in executive session, are clear and audible to all
6	participants in the meeting including the public.
7	(5) Before being allowed to testify, each person appearing before a
8	legislative committee shall swear or affirm that his testimony is true and
9	correct. He shall then be considered to be under oath while providing testimony
10	before the committee and subject to punishment for contempt.
11	D. For the purposes of this Section, the following words and phrases shall
12	have the following meanings:
13	(1) "Meeting via electronic means" shall mean a meeting occurring via
14	teleconference or video conference.
15	(2) "Teleconference" shall mean a method of communication which
16	enables persons in different locations to participate in a meeting and to hear
17	and otherwise communicate with each other.
18	(3) "Video conference" shall mean a method of communication which
19	enables persons in different locations to participate in a meeting and to see,
20	hear, and otherwise communicate with each other.
21	Section 2. This Act shall become effective upon signature by the governor or, if not
22	signed by the governor, upon expiration of the time for bills to become law without signature
23	by the governor, as provided by Article III, Section 18 of the Constitution of Louisiana. If
24	vetoed by the governor and subsequently approved by the legislature, this Act shall become
25	effective on the day following such approval.

<u>Proposed law</u> provides that a member of the legislature or legislative committee may meet and transact business via electronic means provided that the governor has declared a state of emergency or disaster and the nature of the emergency or disaster would cause a meeting of the legislature at the state capitol to be detrimental to the health, safety, or welfare of the public.

<u>Proposed law</u> provides that the presiding officer of the house of which he is a member must certify that the agenda of the meeting is limited to criteria specified in proposed law.

<u>Proposed law</u> provides that at least 24 hours in advance of a meeting held via electronic means its notice and agenda must be posted on the legislative website and distributed upon request to members of the public and media.

<u>Proposed law</u> provides that detailed information regarding public participation be posted on the legislative website and distributed upon request to members of the public and media.

<u>Proposed law</u> provides that the legislature will provide a mechanism for public comment prior to and during any meeting held, properly identify and acknowledge all public comments during the meeting, maintain those comments in its record of the meeting, ensure that each person participating in the meeting is properly identified, and ensure that all parts of the meeting, excluding any matter discussed in executive session, are clear and audible to all participants in the meeting including the public.

<u>Proposed law</u> provides that each person appearing before a legislative committee must swear or affirm that his testimony is true and correct prior to providing testimony.

Proposed law defines the following terms:

- (1) "Meeting via electronic means" shall mean a meeting occurring via teleconference or video conference.
- (2) "Teleconference" shall mean a method of communication which enables persons in different locations to participate in a meeting and to hear and otherwise communicate with each other.
- (3) "Video conference" shall mean a method of communication which enables persons in different locations to participate in a meeting and to see, hear, and otherwise communicate with each other.

Effective upon signature of the governor or lapse of time for gubernatorial action.

- 3. Establish subject matter limitations for remote meetings of the legislature or legislative committee.
