Fingerprints, biometrics, and other identifying information of the applicant shall be submitted to the bureau for 31 qualification and registry, and the bureau shall, upon request of the licensing board 32 33 and after receipt of such fingerprint card and other identifying information from the 34 applicant, make available to the licensing board all arrest and conviction information 35 contained in the bureau's criminal history record and identification files which

- pertain to the applicant for licensure. In addition, the fingerprints shall be forwarded by the bureau to the Federal Bureau of Investigation for a national criminal history 2 3 record check. In accordance with the authority provided for in this Chapter, the costs of providing the information required pursuant to this Section shall be charged by the 5 bureau, as specified in R.S. 15:587(B), to the licensing board for furnishing information contained in the bureau's criminal history record and identification files, 6 7 including any additional cost of providing the national criminal history records check, which pertains to the applicant. The licensing board may impose any or all 8 9 such fees or costs on the applicant."
