MTR VEHICLE/LICEN PLATES: Creates the "Southern Yacht Club" in New Orleans specialty license plate

AN ACT

2	To enact R.S. 47:463.214, relative to motor vehicle special prestige license plates; to
3	establish the "Southern Yacht Club" specialty license plate; to provide for the
4	creation, issuance, design, fees, implementation, distribution, and rule promulgation
5	applicable to such license plate; and to provide for related matters.
6	Be it enacted by the Legislature of Louisiana:
7	Section 1. R.S. 47:463.214 is hereby enacted to read as follows:
8	§463.214. Special prestige license plate; "Southern Yacht Club"
9	A. The secretary of the Department of Public Safety and Corrections shall
10	establish a special prestige motor vehicle license plate to be known as the "Southern
11	Yacht Club" plate, provided there is a minimum of one thousand applicants for such
12	plate. The plate shall be restricted to use on passenger cars, pickup trucks,
13	recreational vehicles, motorcycles, and vans.
14	B. The secretary shall work in conjunction with the general manager of
15	Southern Yacht Club in New Orleans to select the color and design of the plate,
16	provided it is in compliance with R.S. 47:463(A)(3). The design shall include the
17	words "Southern Yacht Club".
18	C. The special prestige license plate shall be issued, upon application, to any
19	citizen of Louisiana in the same manner as any other motor vehicle license plate.

1 D. The department shall collect an annual royalty fee of twenty-five dollars 2 that shall be disbursed in accordance with Subsection E of this Section. This royalty fee shall be in addition to the standard motor vehicle license tax imposed by Article 3 4 VII, Section 5 of the Constitution of Louisiana, and a handling fee of three dollars 5 and fifty cents for each plate to be retained by the department to offset a portion of 6 administrative costs. 7 E. The annual royalty fee shall be collected by the department and forwarded 8 to the Southern Sailing Foundation in New Orleans. The monies received from the 9 royalty fees shall be used to support young sailors beginning their sailing career, 10 advanced competitive sailors, and elite sailors seeking world class competition. In 11 addition, the royalty fees shall be used to assist various programs that introduce 12 sailing to students, underserved youth, and individuals who face physical challenges. F. The secretary shall promulgate and adopt rules and regulations as are 13 14 necessary to implement the provisions of this Section. 15 Section 2. The Department of Public Safety and Corrections, office of motor 16 vehicles, is hereby directed to create the special prestige license plate when the applicable 17 statutory provisions are met and its system is updated to accommodate the creation of new 18 plates.

**Abstract:** Creates the "Southern Yacht Club" special prestige license plate. Provides for the creation, issuance, design, implementation, fees, distribution, and promulgation of rules applicable to this license plate.

<u>Proposed law</u> requires the Dept. of Public Safety and Corrections to issue a special prestige license plate to be known as the "Southern Yacht Club" license plate, provided there is a minimum of 1,000 applicants for such plate.

<u>Proposed law</u> requires that the secretary work in conjunction with the general manager of Southern Yacht Club in New Orleans to select the color and design of the plate.

<u>Proposed law</u> specifies that the license plate will be issued, upon application, to any citizen of La. in the same manner as any other motor vehicle license plate.

CODING: Words in struck through type are deletions from existing law; words <u>underscored</u> are additions.

<u>Proposed law</u> requires the department to collect an annual royalty fee of \$25 in addition to the standard motor vehicle license tax and a \$3.50 handling fee for each plate to be retained by the department to offset a portion of administrative costs.

<u>Proposed law</u> requires monies received from the royalty fees to be forwarded to the Southern Sailing Foundation in New Orleans. Specifies that the monies received from the royalty fees be used to support young sailors beginning their sailing career, advanced competitive sailors, and elite sailors seeking world class competition. Further specifies the royalty fees be used to assist various programs that introduce sailing to students, underserved youth, and individuals who face physical challenges.

<u>Proposed law</u> requires the secretary to promulgate and adopt rules and regulations to implement the provisions provided in <u>proposed law</u>.

Directs the Dept. of Public Safety and Corrections, office of motor vehicles, to create the "Southern Yacht Club" speciality license plate when the applicable statutory provisions are met and its system is updated to accommodate the creation of new plates.
