2 To amend and reenact R.S. 33:9091.25(B) and (D), relative to Orleans Parish; to provide relative to the Delachaise Security and Improvement District; to provide relative to 3 the boundaries and governance of the district; and to provide for related matters. 4 5 Notice of intention to introduce this Act has been published. 6 Be it enacted by the Legislature of Louisiana: 7 Section 1. R.S. 33:9091.25(B) and (D) are hereby amended and reenacted to read 8 as follows: 9 §9091.25. Delachaise Security and Improvement District 10 B. Boundaries. The boundaries of the district shall be that area within and 11 including the following perimeter: beginning at the intersection of Louisiana Ave. 12 13 and Carondelet St. and proceeding along Carondelet St. (both sides) to its intersection with Napoleon Ave., along Napoleon Ave. (interior side) to its 14 intersection with Freret St., then along Freret St. (interior side) to its 15 intersection with Louisiana Ave. Marengo St., along Marengo St. (both sides) to 16 17 its intersection with S. Saratoga St., then along S. Saratoga St. (both sides) to its

1	intersection with Louisiana Ave., and finally along Louisiana Ave. (interior side)
2	back to its intersection with Carondelet St.

4	D. Governance. (1) The district shall be governed by a board of
5	commissioners, referred to in this Section as the "board", consisting of five seven
6	members, all of whom shall be qualified voters and residents of the district,
7	composed as follows:
8	(a) The presidents of the Delachaise Neighborhood Association, referred to
9	in this Section as the "DNA" and the Milan Neighborhood Association, referred
10	to in this Section as the "MNA".
11	(b) The governing board of the <del>Delachaise Neighborhood Association</del> <b>DNA</b>
12	shall appoint three two members who may be members of the governing board.
13	(c) The governing board of the MNA shall appoint two members who
14	may be members of the governing board.
15	(d) The member of the governing authority of the city of New Orleans who
16	represents Council District B shall appoint one member.
17	(2)(a) The members serving pursuant to Subparagraph (1)(a) of this
18	Subsection shall serve during his their term of office.
19	(b) The members appointed pursuant to Subparagraph (1)(b) and (c) of this
20	Subsection shall serve two-year terms after initial terms as provided in this
21	Subparagraph. Two members shall serve an initial term of one year and one member
22	shall serve an initial term of two years, as determined by lot at the first meeting of
23	the board.
24	(c) The member appointed pursuant to Subparagraph (1)(e) (1)(d) of this
25	Subsection shall serve a term concurrent with the appointing authority.

<u>Present law</u> creates the Delachaise Security and Improvement District in Orleans Parish as a political subdivision of the state for the purpose of aiding in crime prevention and providing for overall betterment of the district. Provides for district boundaries. Provides that the district shall be governed by a board of commissioners composed as follows:

- (1) The president of the Delachaise Neighborhood Association (DNA).
- (2) Three members appointed by the governing board of the DNA.
- One member appointed by the member of the governing authority of the city of New Orleans who represents Council District B.

<u>Proposed law</u> retains <u>present law</u> but makes changes to the districts boundaries. <u>Proposed law</u> also makes changes to the boundaries so that the district shall be governed by a board of commissioners composed as follows:

- (1) The presidents of the DNA and the Milan Neighborhood Association (MNA).
- (2) The governing board of the DNA shall appoint two members.
- (3) The governing board of the MNA shall appoint two members.
- One member appointed by the member of the governing authority of the city of New Orleans who represents Council District B.

Effective August 1, 2022.
