UNEMPLOYMENT COMP: Provides relative to the unemployment insurance integrity program

AN ACT

2 To amend and reenact R.S. 23:1605(D) through (G) and to enact R.S. 23:1605 (C)(5), (H), 3 and (I), relative to unemployment compensation; to require the Louisiana Workforce 4 Commission to conduct certain checks with respect to unemployment compensation; 5 to require the recovery of overpayments; and to provide for related matters. 6 Be it enacted by the Legislature of Louisiana: 7 Section 1. R.S. 23:1605(D) through (G) are hereby amended and reenacted and R.S. 8 23:1605(C)(5), (H), and (I) are hereby enacted to read as follows: 9 §1605. Unemployment insurance integrity program 10 11 C. To ensure the integrity of the unemployment insurance program and to 12 verify eligibility and to prevent fraudulent filing and payment of claims, the 13 department is required to do all of the following: 14 15 (5) The department, on a weekly basis, shall check the unemployment 16 insurance rolls against the Louisiana Department of Health State Registrar and Vital 17 Records' list of death records. 18 D. To ensure the integrity of the unemployment insurance program and to 19 prevent the continuous payment of suspicious or potentially improper claims, the

1	department shall perform a review and verify the eligibility of the following claims:
2	(1) Multiple or duplicative claims that are filed online originating from the
3	same internet protocol address.
4	(2) Claims that are filed online from a foreign internet protocol address.
5	(3) Multiple or duplicative claims that are filed and associated with the same
6	mailing address.
7	(4) Multiple or duplicative claims that are filed and associated with the same
8	bank account.
9	D.E. When the department receives information concerning an individual
10	who is participating in the unemployment compensation insurance program that
11	indicates a change in circumstances that may affect his eligibility, the department
12	shall review the individual's case and make a final determination of his eligibility in
13	accordance with the provisions of R.S. 23:1600 and 1601.
14	E.F. Pursuant to the performance of all cross-match activities required by
15	this Section, the Louisiana Workforce Commission shall provide to the legislature
16	a report on or before June thirtieth annually. The report shall include all of the
17	following:
18	(1) The department's rate of consistency in performing the weekly checks
19	against the Integrity Data Hub or another commercially available database and the
20	National Directory of New Hires.
21	(2) The type and amount of improper payments detected retroactively.
22	(3) The type and amount of improper payments prevented.
23	(4) The dollar amount the state has saved in preventing improper payments
24	and, if any, in recouping improper payments.
25	G.(1) The department shall adopt and implement an internal administrative
26	policy to recover improper overpayments to the fullest extent possible by state and
27	federal law.
28	(2) The department shall, without exception, recover improper
29	overpayments, unless doing so would violate existing state or federal law.

F:H. The department shall have the authority to execute a memorandum of understanding with any state department, agency, or division for data that is necessary to carry out the purposes of this Section.

G:I. The Louisiana Workforce Commission shall promulgate all rules and regulations necessary for the purposes of carrying out the provisions of this Section.

Abstract: Provides relative to the unemployment compensation integrity program.

<u>Present law</u> provides that to ensure the integrity of the unemployment insurance program and to verify eligibility and to prevent fraudulent filing and payment of claims, the department (the Louisiana Workforce Commission (LWC) is required to do all of the following:

- (1) Use commercially available database solutions to check new hire records against the state's unemployment insurance rolls on a weekly basis.
- (2) Check new hire records against the National Directory of New Hires.
- (3) Check the Integrity Data Hub or another commercially available database.
- (4) Check the unemployment insurance rolls against the La. Dept. of Public Safety and Corrections' list of incarcerated individuals.

<u>Proposed law</u> retains <u>present law</u> and adds that the department, on a weekly basis, shall check the unemployment insurance rolls against the La. Dept. of Health State Registrar and Vital Records' list of death records.

<u>Proposed law</u> provides that to ensure the integrity of the unemployment insurance program and to prevent the continuous payment of suspicious or potentially improper claims, the LWC shall perform a review and verify the eligibility of the following claims:

- (1) Multiple or duplicative claims that are filed online originating from the same I.P. address.
- (2) Claims that are filed online from a foreign I.P. address.
- (3) Multiple or duplicative claims that are filed and associated with the same mailing address.
- (4) Multiple or duplicative claims that are filed and associated with the same bank account.

<u>Proposed law</u> provides that the department shall adopt and implement an internal administrative policy to recover improper overpayments to the fullest extent possible by state and federal law.
