2 To commend J. Stephen Perry for his contributions and service to state of Louisiana, the city 3 of New Orleans, and the tourism industry. 4 WHEREAS, J. Stephen Perry is the president and chief executive officer of New 5 Orleans & Company; he holds a bachelor of arts degree in Russian and French history and 6 a master of arts degree in anthropology from Louisiana State University; he studied twice 7 in the former Soviet Union and completed the Senior Executives Program in State and Local 8 Government offered by the Kennedy School of Government at Harvard University; and 9 WHEREAS, under J. Stephen Perry's leadership over the last twenty years, New 10 Orleans & Company, which was formerly known as New Orleans Convention and Visitors 11 Bureau, has routinely ranked among the top five convention and visitors bureaus in the 12 country; his tenure as leader has seen the company receive multiple national awards for 13 excellence in sales, marketing, public relations, branding, customer service, and corporate 14 relations; and 15 WHEREAS, J. Stephen Perry's many successes come with significant 16 responsibilities; the brand management, marketing, and sales of New Orleans & Company 17 are vital to the sustenance and enhancement of nearly ninety thousand jobs in the city's 18 tourism industry and one thousand one hundred member businesses of New Orleans & 19 Company; moreover, the efforts of the company combined with tourism help to generate 20 significant revenues for both the city of New Orleans and the state of Louisiana; and

1	WHEREAS, J. Stephen Perry helped lead the rebuilding of tourism in New Orleans
2	following the devastation left in the wake of Hurricane Katrina, the BP Oil Spill, and
3	Hurricane Ida, and he is currently working to do the same as the state of Louisiana continues
4	to manage the spread of the pandemic; and
5	WHEREAS, J. Stephen Perry is an exceptionally civic-minded individual who has
6	held seats on numerous advisory boards; he was appointed by both President George W.
7	Bush and President Barack Obama to the U.S. Travel and Tourism Advisory Board, has
8	served on the Louisiana State University Board of Supervisors for more than a decade, has
9	served as a longtime member on the board of the U.S. Travel Association, and continues to
10	serve on the boards of the New Orleans Museum of Art, Louisiana Travel Association, the
11	Louisiana Museum Foundation, and Audubon Nature Institute, among others; and
12	WHEREAS, J. Stephen Perry served as chief of staff to former Louisiana Governor
13	Murphy J. "Mike" Foster, Jr. from the time of his election in November 1995 until August

16	relocation of the New Orleans Hornets/Pelicans NBA franchise, and the building of the PGA
17	Tour Tournament Players Club in Greater New Orleans, which hosts the Zurich Classic PGA
18	Tour event; and
19	WHEREAS, J. Stephen Perry has committed the last twenty years to bettering the
20	city of New Orleans and the state of Louisiana; he has impacted both the city of New
21	Orleans and the state of Louisiana in countless ways and is most deserving of the highest
22	recognition for his incredible service.
23	THEREFORE, BE IT RESOLVED that the House of Representatives of the
24	Legislature of Louisiana does hereby commend J. Stephen Perry for his contributions and
25	service to state of Louisiana, the city of New Orleans, and the tourism industry; does hereby
