Repeals provisions relative to the tracking and reporting of unpaid judgments against the state

Proposed law repeals present law that requires the Division of Administration (DOA) and the Attorney General/Department of Justice to maintain a list of all unpaid final judgments against the state and required the information on the list to be included in the state's comprehensive annual financial report. Proposed law repeals present law that requires (1) agencies, boards, and commissions who retain private legal counsel to represent them to maintain accurate data on legal contracts, costs, and final judgments and to submit the data to the Attorney General/Department of Justice on a regular basis, (2) the Attorney General/Department of Justice to keep an accurate account of the data and to regularly report the data to the legislature, and (3) the attorney of record or the prevailing party in a case where private legal counsel has been retained to submit a certified copy of the final judgment to the Senate Committee on Finance and the House Committee on Appropriations. Proposed law effective 7/01/22.
