 Provides relative to high school core curriculum requirements. (gov sig)

Proposed legislation modifies the high school core curriculum requirements for TOPS Opportunity, Performance, and Honors Awards for students graduating during or after the 2025-26 school year. Allows the currently required two units of a foreign language to be replaced with two units of computer science courses. Provides a list of acceptable courses. Effective upon governor's signature.
