An 4 order setting the hearing shall provide for appointment of counsel for the child and notice to the program entity approved to represent children. If a an instanter safety 5 plan order has been ordered a hearing shall be held by the court within three days 6 7 from the issuance of the safety plan order, unless the parents are in agreement with the safety plan. The parents' signature on the safety plan shall constitute evidence 8 9 of their agreement with the plan. The continued safety plan hearing shall be conducted in accordance with the procedural and evidentiary rules applicable to 10 11 continued custody hearings."
