9 AMENDMENT NO. 5

10 On page 8, between lines 15 and 16, insert the following:

 12 Dedications out of the Matching Funds Fund to the  
 13 Drinking Water Revolving Loan Fund Program to  
 14 use as state match for the Drinking Water Revolving  
 15 Loan Fund allocations found in the federal  
 16 Infrastructure Investment and Jobs Act, in the event  
 17 that House Bill No. 406 of the 2022 Regular Session  
 18 of the Legislature is enacted into law \$ 2,693,000"
