APPROPRIATIONS/SUPPLEML: Makes supplemental appropriations for Fiscal Year 2021-2022

1 AN ACT

2 To appropriate funds and to make certain reductions from certain sources to be allocated to
3 designated agencies and purposes in specific amounts for the making of
4 supplemental appropriations and reductions for said agencies and purposes for Fiscal
5 Year 2021-2022; to provide for an effective date; and to provide for related matters.

6 Be it enacted by the Legislature of Louisiana:

10 Section 3. Notwithstanding any provision of law to the contrary, any appropriation
11 contained in Other Requirements, Schedule 20-901 Sales Tax Dedications in Act 119 of the
12 2021 Regular Session of the Legislature for the city of Westwego which has a valid
13 Cooperative Endeavor Agreement on June 29, 2022, shall be deemed a bona fide obligation
14 of the state through June 30, 2023, and all provisions of the Cooperative Endeavor

17 Section 4. The following revision is hereby made to Act No. 119 of the 2021 Regular
