15 (2) The board shall adopt rules to require that, beginning with the 2021-2022 school year, all public and approved nonpublic school teachers, school counselors, 16 principals, and other school administrators for whom the training is considered 17 beneficial by the board shall annually participate in at least one hour of in-service 18 19 training on recognizing adverse childhood experiences and the utilization of traumainformed adverse childhood experience education. The in-service training required 20 by this Paragraph shall be provided on a day that other types of in-service training 21 will be provided in accordance with the school calendar adopted by each public 22 23 school governing authority.
