A CONCURRENT RESOLUTION

To commend Dr. Jeremy Kamil on his contributions to Louisiana State University and the state of Louisiana.

WHEREAS, Dr. Jeremy Kamil is an associate professor of microbiology and immunology at Louisiana State University Health Sciences Center Shreveport who has gained national recognition for his subject expertise and advocacy of the irreplaceable role that the genome sequencing of the SARS-CoV-2 virus plays in combating both the current COVID-19 pandemic and potential future pandemics; and

WHEREAS, Dr. Kamil is an internationally recognized subject matter expert in the study of virology and virus sequencing; he has been featured in a number of media outlets such as *The Washington Post*, *The New York Times*, *The Wall Street Journal*, *BBC*, *Forbes Magazine*, *Fortune Magazine*, *Popular Science*, *Nature*, *NPR*, and *Newsweek*; and

WHEREAS, Dr. Kamil's fellowships in biological chemistry and molecular pharmacology research at Harvard Medical School and in microbiology and immunology at Cornell University provided him with an educational and experiential foundation that has helped him earn, since 2008, consistent funding from the National Institutes of Health; and

WHEREAS, Dr. Kamil is currently the principal investigator of a grant from The Rockefeller Foundation which established a regional genomic surveillance network to increase the volume and diversity of SARS-CoV-2 samples sequenced; he engaged Grambling State University, Mercer University, and Louisiana Tech University to expand sequencing efforts and tracking of COVID-19 variants; and

WHEREAS, LSU Health Sciences Center Shreveport is playing an active role in assisting The Rockefeller Foundation's Pandemic Prevention Institute in obtaining fast and

accurate genome sequencing data; this data is crucial in the efforts to end the COVID-19

pandemic and to better prepare for and mitigate future pandemic threats; and

WHEREAS, Dr. Kamil was selected to serve on the G7 Open Science Working

Group's global efforts to identify lessons learned from the COVID-19 pandemic experience,

particularly lessons regarding the sharing of viral genomic data as well as the key barriers

or challenges that prevent data sharing; and

WHEREAS, Dr. Kamil is worthy of commendation for the positive recognition he

has brought to Louisiana State University and the state of Louisiana as a result of his global

contributions to better practices in addressing public health emergencies, improving cross-

border research collaboration, and developing policies that will benefit pandemic responses

for generations to come.

THEREFORE, BE IT RESOLVED that the Legislature of Louisiana does hereby

commend Dr. Jeremy Kamil on his contributions to Louisiana State University and the state

of Louisiana; does hereby further recognize Dr. Kamil for his truly inspirational efforts to

he and his fellow researchers continue to receive the support needed to continue their

incredible humanitarian work.
