| 7 | Section 1. R.S. 33:1377 is hereby enacted to read as follows: |
| 8 | §1377. Liquefied petroleum gas; parishes and municipalities |
| 9 | A. The regulation of a liquefied petroleum gas dealer's authority to operate |
| 10 | and serve customers is a matter of statewide concern. No code, ordinance, land use |
| 11 | restriction, or general or specific plan provision or part of a code, ordinance, land use |
| 12 | regulation, or general or specific plan provision adopted by a parish or municipality |
| 13 | may prohibit or have the effect of restricting a person's or entity's ability to use the |
| 14 | services of a liquefied petroleum gas provider who is capable and authorized to |
| 15 | provide the service at the person's or entity's property. |
| 16 | B. A parish or municipality may not deny a permit application based on the |
| 17 | liquefied petroleum gas dealer's proposal to provide service to the project. |
| 18 | C. A parish or municipality may establish rules, ordinances, or requirements |
| 19 | that do not supercede and are not in conflict with existing federal or state laws, rules |
| 20 | or regulations regarding the use or storage of liquefied petroleum gas. |

Abstract: Prohibits parishes and municipalities from adopting certain rules and regulations that restrict the use and storage of liquefied petroleum gas (LPG).

<u>Proposed law</u> provides that no code, ordinance, land use restriction, or general or specific plan provision adopted by a parish or municipality may prohibit or have the effect of restricting a person's or entity's ability to use the services of a LPG provider who is capable and authorized to provide services to the person's or entity's property.

<u>Proposed law</u> prohibits a parish or municipality from denying a permit application based on the LPG dealer's proposal to provide service to the project. Authorizes a parish or municipality to establish rules, ordinances, or requirements that do not supercede or conflict with existing federal or state laws, rules or regulations regarding the use or storage of LPG.
