ALCOHOLIC BEVERAGES: Provides relative to delivery of alcohol

2	To amend and reenact R.S. 26:274(A)(2), relative to alcohol beverage control; to provide
3	relative to permits for dealers in beverages of low alcohol content; to provide relative
4	to local permits; to provide for exceptions for delivery; and to provide for related
5	matters.
6	Be it enacted by the Legislature of Louisiana:
7	Section 1. R.S. $26:274(A)(2)$ is hereby amended and reenacted to read as follows:
8	§274. Local permits
9	A.(1) Parishes and municipalities may issue and require local permits similar
10	to those issued by the commissioner and may charge and collect fees therefor. No
11	parish or municipality shall require permits of any commercial airline which has
12	been issued a Class B retailer permit.
13	(2) Parishes and municipalities may issue and require local permits similar
14	to those issued by the commissioner for the delivery of alcoholic beverages by
15	grocery stores, restaurants, and third parties. Parishes and municipalities shall not
16	require a local permit for any third-party delivery company which has been issued
17	a state delivery service permit in accordance with the provisions of this Chapter.
18	Parish and municipalities shall not require an additional local permit for the delivery
19	of alcohol beverages by any licensed retail dealer that has been issued a state
20	delivery service permit in accordance with the provisions of this Chapter. No

Abstract: Prohibits parishes and municipalities from requiring local permits for the delivery of alcoholic beverages by third-party permit holders.

<u>Present law</u> (R.S. 26:274) provides that parishes and municipalities may issue and require local permits and may charge and collect fees for such permits. <u>Present law</u> prohibits parishes or municipalities from requiring permits for any commercial airline that has been issued a Class B retailer permit.

<u>Present law</u> provides that parishes and municipalities may issue permits similar to those issued by the commissioner for the alcoholic beverage delivery by grocery stores, restaurants, and third parties.

<u>Proposed law</u> retains <u>present law</u> and provides that parishes and municipalities shall not require local permits for the delivery of alcoholic beverages of any licensed third-party delivery companies that have been issued a delivery service permit by the state.

<u>Present law</u> (R.S. 26:271.4) provides for the issuing of Class B Package House permits allowing for the delivery of alcohol by grocery stores.

<u>Present law</u> (R.S. 26:271.3) provides for the issuance of Class C Package Store permits to establishments that meet certain requirements including selling alcoholic beverages for offpremise consumption and not distributing motor fuel at the licensed establishment.

<u>Proposed law</u> prohibits the delivery of alcoholic beverages more than 20 miles from the place of purchase.

Summary of Amendments Adopted by House

The Committee Amendments Proposed by <u>House Committee on Judiciary</u> to the <u>original</u> bill:

- 1. Change the <u>proposed law</u> exemption from local permits for Class A, B, and C retailers to an exemption for all third-party delivery companies that have been issued a state permit.
- 2. Prohibit delivery more than 20 miles from the place of purchase.
