GAMING EG NO IMPACT See Note Suspends certain requirements regarding the landbased casino contract. (gov sig)

<u>Current law</u> requires the contract with the casino gaming operator of the land-based casino to include the requirements that the operator will not reduce total operating workforce in the casino below 90% and total salaries by more than 10% of the levels in place on March 8, 2001. Workforce and salaries may include certain employees and salaries from parent, subsidiaries, affiliates, 3rd party tenants and subtenants. The contract has been executed containing these minimum requirements for workforce and salaries.

<u>Proposed law</u> suspends the statutory requirement that the operator contract with the land-based casino contain workforce and salary minimums between July 1, 2022, through June 30, 2024.
