1	B. Any medical necessity determination made by a Medicaid managed care
2	organization shall be in compliance with the Paul Wellstone and Pete Domenici
3	Mental Health Parity and Addiction Equity Act of 2008 and its related regulations,
4	and in accordance with the Medicaid Managed Care Independent Claims Review
5	Process, R.S. 46:460.81 et seq.
6	C. As used in this Section, the following terms apply:
7	(1) "Managed care organization" means the same as the term is defined in
8	R.S. 46:460.31.
9	(2) "Medicaid" means the same as the term is defined in R.S. 46:460.31.
10	(3) "Mental health or substance abuse benefits" means benefits for the
11	treatment of any condition or disorder that involves a mental health condition or
12	substance use disorder that falls under any of the diagnostic categories listed in the
13	mental disorders section of the current edition of the International Classification of
14	Diseases or that is listed in the mental disorders section of the most recent version
15	of the Diagnostic and Statistical Manual of Mental Disorders.
16	(4) "Psychiatric Collaborative Care Model" means the evidence-based,
17	integrated behavioral health service delivery method described in 81 FR 80230."
