AN ACT

1 2 To amend and reenact R.S. 40:1379.1(N) and to enact Chapter 12 of Title 24 of the Louisiana Revised Statutes of 1950, to be comprised of R.S. 24:681 through 685 and 3 691 through 693 and R.S. 40:2402(3)(f), relative to capitol security; to provide for 4 5 a director of capitol security; to provide for the qualifications, compensation, duties and functions of the director; to provide for capitol security officers; to provide for 6 the manner in which certain special officer commissions may be issued; to create the 8 Capitol Security Council; to provide for the composition and membership of the 9 council; to provide for the powers and duties of the council; to provide for 10 definitions; and to provide for related matters. 11 Be it enacted by the Legislature of Louisiana: Section 1. Chapter 12 of Title 24 of the Louisiana Revised Statutes of 1950, 12 13 comprised of R.S. 24:681 through 685 and 691 through 693 is hereby enacted to read as follows: 14 15 **CHAPTER 12. 1 §681. Capitol security director; qualifications; compensation 2 A. There shall be a director of capitol security who shall be the chief security officer for the legislature. The director of capitol security shall be 3 elected by the favorable vote of a majority of the elected members of each house 4 5 of the legislature, after having been interviewed by the Capitol Security Council and recommended for employment by the council by a majority vote, and shall 6 7 serve at the pleasure of the legislature. He may be removed by a majority vote 8 of the elected members of each house of the legislature. Any vacancy occasioned 9 by death, resignation, or otherwise, which occurs while the legislature is not in 10 session, shall be filled on a temporary basis by the president of the Senate and 11 the speaker of the House of Representatives, until such time as the vacancy shall 12 be filled by the legislature as provided in this Subsection. 13 B. The director shall have a minimum of ten years of full-time law enforcement experience. He shall be POST-certified and possess qualifications 14 15 necessary to be commissioned as a special officer. He shall not be a member of 16 the legislature. C. The salary of the director of capitol security shall be recommended 17 by the Capitol Security Council, and together with all other expenses and 18 19 salaries of his office necessary to carry out the duties required pursuant to R.S. 20 24:682, shall be submitted to the president of the Senate and the speaker of the 21 House of Representatives for approval. 22 §682. Duties and functions A. Responsibility to legislature; lead investigative officer; supplemental 14 15 operating funds 16 A. The director of capitol security shall, in every aspect of his functions, duties, and operations, be responsible solely to the legislature and to no other 17 branch of state government and no board, commission, department, or agency 18 19 or official of any other branch of state government. 20 B. Notwithstanding any other law to the contrary, the director shall be 21 the lead investigative officer for any security breach or occurrence in the state 22 capitol building and the parts of the state capitol complex used by the 23 legislature, its members, and staff. 24 C. The designation of the director of capitol security as the chief capitol security officer for the legislature shall not otherwise affect the duties of the 25 sergeant at arms of the Senate or the House of Representatives as provided in 26 27 the Rules of Order of the Senate or the Rules of Order of the House of 28 Representatives.

Contempt of council; authority to conduct proceedings 11 Failure to comply with any order of the council issued in accordance 12 with or under the authority of this Chapter, refusal to testify, or any act of 13 disrespect or of disorderly or contemptuous behavior before the council shall constitute contempt of the council. Definitions 3 As used in this Chapter: 4 5 (3) (f) "Peace officer" shall also include the director of capitol security and 6 7 security officers employed by the legislature upon recommendation of the 8 director as provided by R.S. 24:861 et seq. 9 10 Section 3. This Act shall become effective upon signature by the governor or, if not 11 signed by the governor, upon expiration of the time for bills to become law without signature by the governor, as provided by Article III, Section 18 of the Constitution of Louisiana. If 12 13 vetoed by the governor and subsequently approved by the legislature, this Act shall become effective on the day following such approval. 14

<u>Proposed law</u> creates the director of capitol security as the chief security officer for the legislature. Provides for the election of the director upon a favorable majority of the elected members of each house of the legislature after having been interviewed by the Capitol Security Council and recommended for employment by the council by a majority vote. Provides that the director shall serve at the pleasure of the legislature and may be removed by a majority vote of the elected members of each house of the legislature. Provides that any vacancy which occurs while the legislature is not in session shall be filled temporarily by the president of the Senate and the speaker of the House of Representatives, until such time as the vacancy is filled by the legislature.

<u>Proposed law</u> provides that the director shall have 10 years of full-time law enforcement experience, shall be POST-certified, and shall possess qualifications necessary to be commissioned as a special officer. He shall not be a member of the legislature.

<u>Proposed law</u> provides that the salary of the director shall be recommended by the Capitol Security Council. Requires all other necessary expenses and salaries of the council to be submitted to the president of the Senate and speaker of the House of Representatives for approval.

Proposed law provides for the duties of the director. Specifies that the director shall:

(1) Oversee law enforcement and physical security for the parts of the state capitol building and state capitol complex that are used by the legislature.

- Oversee law enforcement and physical security at any official meeting or function of the legislature, or its committees, regardless of location.
- (3) Develop an annual budget for the operations of the office, subject to approval by the council.
- (4) Recommend employment for security officers and other personnel necessary to ensure the physical security of the parts of the state capitol building and state capitol complex that are used by the legislature.
- (5) Ensure that security officers are POST-certified and possess qualifications necessary to be commissioned as special officers.
- (6) Develop, coordinate, and implement security training for security officers.
- (7) Coordinate and supervise the scheduling and activities of the security officers.
- (8) Respond and act with regard to any security event within his area of jurisdiction.
- (9) Conduct investigations and affect lawful arrests.
- (10) Conduct research, analyze and interpret data, monitor compliance with administrative rules and regulations, make findings of fact, prepare reports, and recommend legislation, policies, and directives which relate to security.
- (11) Act as the legislature's principal point of contact for all law enforcement recommendations to the legislature.
- (12) Develop a comprehensive security plan for the state capitol.
- (13) Carry out all directives issued by either legislative house or the committees relative to security issues.

<u>Proposed law</u> provides that the offices of the director shall be domiciled in the state capitol complex.

<u>Proposed law</u> provides that the director shall be responsible solely to the legislature in his functions and duties and shall be the lead investigative officer in any security breach or occurrence in the state capitol building. Specifies that the designation of the director as chief capitol security officer shall not otherwise affect the duties of the sergeant at arms of the Senate or the House of Representatives.

<u>Proposed law</u> creates the Capitol Security Council composed of the president of the Senate, four members from the Senate appointed by the president, the speaker of the House of Representatives, and four members from the House of Representatives appointed by the speaker. Authorizes the presiding officers of each house of the legislature to select a chairman and vice chairman. Provides that the chairmanship and the vice chairmanship rotate between the Senate and the House of Representatives every two years. Provides that the council determines the qualifications of the director of capitol security.

<u>Proposed law</u> provides for the duties of the council and specifies that the council is responsible for adopting a comprehensive security plan for the parts of the state capitol building and state capitol complex used by the legislature. Requires the council to review and approve the annual budget for the operations of the director prior to submission of the budget to the president and speaker and to fix the salary of the director.

<u>Proposed law</u> invests the council with the power to hold hearings, administer oaths, take public testimony, and pursue punishment for contempt as provided by law.

<u>Present law</u> provides that the deputy secretary of public safety services shall issue a special officer's commission to the sergeant at arms or assistant sergeants at arms of the Senate or the House of Representatives when directed to do so by the president of the Senate or speaker of the House of Representatives.

<u>Proposed law</u> retains <u>present law</u> and further provides that capitol security officers shall also be issued a special officer's commission upon direction of the president of the Senate or speaker of the House of Representatives.

<u>Proposed law</u> adds the director of capitol security and security officers employed by the legislature upon his recommendation to the definition of peace officer.

Effective upon signature of the governor or lapse of time for gubernatorial action.

(Amends R.S. 40:1379.1(N); adds R.S. 24:681-685 and 691-693 and R.S. 40:2402(3)(f))
