6	WHEREAS, there are currently more than ninety-two thousand people in Louisiana
7	over the age of sixty-five living with Alzheimer's disease; and
8	WHEREAS, Louisiana has the tenth highest Alzheimer's disease death rate in the
9	country; and
10	WHEREAS, there are currently two hundred three thousand caregivers in Louisiana
11	providing three hundred sixteen million hours of unpaid care; and
12	WHEREAS, Medicaid costs the state seven hundred sixty-five million dollars to care
13	for people with Alzheimer's disease; and
14	WHEREAS, Medicare costs the state thirty thousand seven hundred eighty-six
15	dollars per capita for people with dementia.
16	THEREFORE, BE IT RESOLVED that the Legislature of Louisiana does hereby
17	urge and request the Louisiana Alzheimer's Coalition to submit its Alzheimer's state plan to
18	the office of the governor, speaker of the House of Representatives, president of the Senate,
19	chairman of the House Committee on Health and Welfare, and chairman of the Senate
20	Committee on Health and Welfare no later than March 31, 2023.
