2	To commend Brady Hall on achieving the rank of Eagle Scout.
3	WHEREAS, it is most fitting to commend and celebrate the accomplishments of
4	Brady Hall of Boy Scouts of America Troop 29 on the memorable and historic occasion of
5	his attainment of the prestigious rank of Eagle Scout; and
6	WHEREAS, Brady Hall achieved the status of Eagle Scout and was honored at an
7	Eagle Court of Honor Ceremony in Welsh, Louisiana; he has been a member of Troop 29
8	for eleven years; and
9	WHEREAS, the mission of the Boy Scouts of America, founded on February 8,
10	1910, and chartered by the United States Congress in 1916, is to prepare young people to
11	make ethical and moral choices over their lifetimes by instilling in them the values of the
12	Scout Oath and Law; and
13	WHEREAS, to earn the rank of Eagle Scout, the highest rank in Scouting, a Boy
14	Scout must fulfill all requirements of leadership, service, and outdoor skills and must earn
15	twenty-one merit badges which signify the mastery of Scouting skills, including Citizenship
16	in the Community, Citizenship in the Nation, and Citizenship in the World; and
17	WHEREAS, Brady faithfully embodies the twelve points of the Scout Law: he is
18	trustworthy, loyal, helpful, friendly, courteous, kind, obedient, cheerful, thrifty, brave, clean,
19	and reverent; and
20	WHEREAS, presented with his Eagle Scout badge, Brady Hall joins the ranks of
21	such esteemed and respected Eagle Scouts as the Honorable Gerald R. Ford, the thirty-eighth
