31	(b) The total expenditures of monies held by the state in a fiduciary capacity,
32	to the extent not excluded pursuant to the provisions of Paragraph (1) of this
33	Subsection.
34	(c) Each expenditure of funds from an appropriation for a prior fiscal year
35	made by legislative act which appropriation has been carried forward into the current
36	fiscal year, to the extent not excluded pursuant to the provisions of Paragraph (1) of
37	this Subsection."
