MUSEUMS/STATE MUSEUM: Establishes the Dew Drop-America's Rock and Roll Museum within the Department of Culture, Recreation and Tourism

1	AN ACT	
2	To enact Chapter 5-G of Title 25 of the Louisiana Revised Statues of 1950, to be comprised	
3	of R.S. 25:380.41 through 45, and R.S. 36:209(C)(5), relative to museums; to	
4	establish the Dew Drop-America's Rock and Roll Museum as a facility within	
5	Orleans Parish; to place the museum within the Department of Culture, Recreation	
6	and Tourism; to provide for an effective date; and to provide for related matters.	
7	Be it enacted by the Legislature of Louisiana:	
8	Section 1. Chapter 5-G of Title 25 of the Louisiana Revised Statues of 1950,	
9	comprised of R.S. 25:380.41 through 45, is hereby enacted to read as follows:	
10	CHAPTER 5-G. DEW DROP-AMERICA'S ROCK AND ROLL MUSEUM	
11	§380.41. Establishment and location: purpose and use	
12	A. The Dew Drop-America's Rock and Roll Museum, referred to in this	
13	Chapter as the "museum", is established as a facility in the parish of Orleans, within	
14	the Department of Culture, Recreation and Tourism, referred to in this Chapter as the	
15	"department", as more specifically provided in this Chapter.	
16	B. The museum shall be a historical, cultural, scientific, and technological	
17	educational institution whose primary purpose shall be to research, collect, preserve,	
18	and present, as an educational resource, the music, recordings, pictures, documents,	
19	artifacts, objects of art, and the like that reflect the social, cultural, and economic

1	history of rock and roll music in the state of Louisiana and in the Orleans Parish area		
2	in particular.		
3	<u>§380.42.</u> Governing board		
4	A. The board of directors of the museum, referred to in this Chapter as the		
5	"board", is hereby created as a body corporate within the department. The board		
6	shall have and exercise all powers, duties, functions, and responsibilities authorized		
7	for it by law.		
8	B. The board is comprised as follows:		
9	(1) The lieutenant governor shall appoint one member.		
10	(2) The LaSalle Cultural Corridor Commission shall appoint one member.		
11	(3) The mayor of New Orleans shall appoint one member.		
12	(4) The New Orleans city council shall appoint one member.		
13	(5) The board of trustees of the Recording Academy shall appoint one		
14	member.		
15	(6) The speaker of the House of Representatives or his designee.		
16	(7) The president of the Senate or his designee.		
17	(8) The members of the board appointed pursuant to Paragraphs (1) through		
18	(7) of this Subsection shall appoint two members who represent cultural institutions		
19	or culture-sector industries in Louisiana.		
20	$\underline{C.(1)}$ Members of the board shall serve four-year terms after initial terms as		
21	provided in this Paragraph. Two members shall serve an initial term of one year, one		
22	shall serve an initial term of two years, one shall serve an initial term of three years,		
23	and one shall serve an initial term of four years, as determined by lot at the first		
24	meeting of the board.		
25	(2) Members shall serve without compensation.		
26	(3) A majority of the board shall constitute a quorum for the transaction of		
27	official business. All official actions of the board shall require the affirmative vote		
28	of a majority of the members present and voting.		

1	D. The board shall:	
2	(1) Meet at least three times a year at the call of the board chairman.	
3	(2) Adopt bylaws, which shall include provisions for the following:	
4	(a) The election and responsibilities of the officers of the board, including	
5	a chairman and vice chairman, who shall serve terms of two years. The member	
6	appointed pursuant to Paragraph $(A)(6)$ of this Section shall call the first meeting of	
7	the board of directors and serve as the chairman until the election of a chairman in	
8	accordance with this Subparagraph.	
9	(b) The selection and responsibilities of advisors to the board. The board	
10	may appoint not more than five advisors who shall serve without compensation.	
11	(c) The appointment, duties, and functions of standing and special	
12	committees of the board, including the appointment of nonboard members to such	
13	committees and their functions.	
14	(3) Establish and use an identifying seal pertaining to museum business.	
15	(4) Perform such other functions as are otherwise provided by this Chapter.	
16	E. The board may:	
17	(1) Incur debt.	
18	(2) Sue and be sued.	
19	(3) Adopt, use, and alter at will a corporate seal.	
20	(4) Adopt bylaws and rules and regulations.	
21	(5) Receive by gift, grant, donation, or otherwise any sum of money,	
22	property, aid, or assistance from the United States, the state of Louisiana, or any	
23	political subdivision thereof, or any person, firm, or corporation.	
24	(6) Enter into contracts, agreements, or cooperative endeavors with the state	
25	and its political subdivisions or political corporations and with any public or private	
26	association, corporation, business entity, or individual. Pursuant to such a contract,	
27	the department may offer technical assistance and operational support to the board.	
28	(7) Elect officers and appoint agents and employees, prescribe their duties,	
29	and fix their compensation.	

1	(8) Acquire property by purchase, gift, grant, donation, or lease.		
2	(9) Establish monetary, bank, and investment accounts.		
3	(10) Perform or have performed any other function or activity necessary or		
4	appropriate to carry out and effectuate the purposes and provisions of this Chapter.		
5	§380.43. Operating funds; appropriations by the legislature		
6	The department may include in its annual budget request, required by R.S.		
7	39:32, a request for funds necessary for support of the museum. The governor shall		
8	include in the executive budget submitted to the legislature sufficient funding for the		
9	support of operations and maintenance of the museum and its exhibits.		
10	§380.44. Donations and loans; disposition of property		
11	A. The board may individually or in cooperation with any nonprofit		
12	corporation established to support the museum and its activities solicit and accept		
13	funds, governmental grants, donations, and contributions of lands, buildings, monies,		
14	artifacts, relics, audio and video recordings, motion picture films, works of art, or		
15	other property on behalf of and as additions to the museum either in the form of		
16	loans or in the form of donations inter vivos or mortis causa, and the department may		
17	acquire them by purchase, lease, or otherwise, subject to the terms, conditions, or		
18	limitations contained in the instrument by which such property is acquired.		
19	However, the museum, through the department or a nonprofit formed to support the		
20	programs and activities of the museum, may enter into any and all contracts with any		
21	person, lender, or donor that it deems fit, proper, and necessary to accept and receive		
22	such lands, buildings, monies, artifacts, relics, audio and video recordings, motion		
23	picture films, works of art, or other property on behalf of, as additions to, or for the		
24	benefit of the museum. The museum may serve as the beneficiary of any public or		
25	private trust or insurance policy created for such purpose, pursuant to the provision		
26	<u>of R.S. 9:2341 et seq.</u>		
27	B. The board is granted the authority of deaccession with respect to any		
28	collection of the museum, and for such purpose is exempted from laws relative to the		

1	sale or disposal of surplus property. The board shall establish policies and	
2	procedures necessary to carry out this authority in an orderly manner.	
3	C.(1) Any property that has been deposited with the museum by loan of	
4	otherwise, that has been held by the museum for more than ten years, and that n	
5	person has made claim shall be deemed to be abandoned and, notwithstanding the	
6	provisions of Chapter 1 of Title XII of Book III of the Louisiana Civil Code, shall	
7	escheat to and become the property of the museum, if the board complies with	
8	Paragraph (2) of this Subsection.	
9	(2)(a) At least once each week for two consecutive weeks, the board shall	
10	cause to be published in at least one newspaper of general circulation in the parish	
11	of Orleans a notice and listing of the property.	
12	(b) The notice shall contain:	
13	(i) The name and last known address, if any, of the last known owner or	
14	depositor of the property.	
15	(ii) A description of the property.	
16	(iii) A statement that if proof of claim is not presented by the claimant to the	
17	board and if the claimant's right to receive such property is not established to the	
18	satisfaction of the board within sixty-five days from the date of the second published	
19	notice, the property will be deemed to be abandoned and shall become the property	
20	of the museum.	
21	(3) If no valid claim has been made to the property within sixty-five days	
22	from the date of the second published notice, title to the property shall escheat to and	
23	vest in the museum free from all claims.	
24	§380.45. Use of collections and property	
25	Any collection or other property of the museum may, subject to approval of	
26	the board, be lent in part. The board shall ensure proper safeguards for its	
27	maintenance and return and shall ensure that proper records are kept. The collection	
28	or other property shall be available for use in educational projects, subject to the	
29	approval of the board.	

1	Section 2. R.S. 36:209(C)(5) is hereby enacted to read as follows:		
2	§209. Transfer of boards, commissions, departments, and agencies to Department		
3	of Culture, Recreation and Tourism		
4	* * *		
5	C. The following agencies are hereby placed within the Department of		
6	Culture, Recreation and Tourism and shall exercise and perform their powers, duties,		
7	functions, and responsibilities in accordance with the provisions of R.S. 36:801.1:		
8	* * *		
9	(5) Board of directors of the Dew Drop-America's Rock and Roll Museum		
10	<u>(R.S. 25:380.41 et seq.).</u>		
11	* * *		
12	Section 3. This Act shall become effective upon signature by the governor or, if not		
13	signed by the governor, upon expiration of the time for bills to become law without signature		
14	by the governor, as provided by Article III, Section 18 of the Constitution of Louisiana. If		
15	vetoed by the governor and subsequently approved by the legislature, this Act shall become		
16	effective on the day following such approval.

Abstract: Establishes the Dew Drop-America's Rock and Roll Museum as a facility in Orleans Parish.

<u>Proposed law</u> establishes the Dew Drop-America's Rock and Roll Museum as a facility in the parish of Orleans. Provides that the museum shall research, collect, preserve, and present, as an educational resource, the music, recordings, pictures, documents, artifacts, objects of art, and the like that reflect the social, cultural, and economic history of rock and roll music in the state and in the Orleans Parish area in particular.

<u>Proposed law</u> creates the board of directors of the museum to govern the museum. Provides that the board is comprised as follows:

- (1) The lieutenant governor shall appoint one member.
- (2) The LaSalle Cultural Corridor Commission shall appoint one member.
- (3) The mayor of New Orleans shall appoint one member.

- (4) The New Orleans city council shall appoint one member.
- (5) The board of trustees of the Recording Academy shall appoint one member.
- (6) The speaker of the House of Representatives or his designee.
- (7) The president of the Senate or his designee.
- (8) The members of the board appointed as provided above shall appoint two members who represent cultural institutions or culture-sector industries in La.

Proposed law provides that members serve four-year staggered terms without compensation.

Proposed law requires the board to:

- (1) Meet at least three times a year at the call of the board chairman.
- (2) Adopt bylaws.
- (3) Establish and use an identifying seal pertaining to museum business.

<u>Proposed law</u> specifies that the board of directors is created as a body corporate and grants it powers typical of corporate bodies including the power to acquire and posses property, enter contracts, adopt bylaws, and elect officers.

<u>Proposed law</u> authorizes the Dept. of Culture, Recreation and Tourism to include in its annual budget request a request for funds necessary for support of the museum. Further requires the governor to include in the executive budget sufficient funding for the support of operations and maintenance of the museum and its exhibits.

<u>Proposed law</u> authorizes the board, individually or in cooperation with a nonprofit corporation formed to support the museum, to solicit and accept funds and other property for the museum either as loans or donations and provides with respect thereto. Authorizes the museum to serve as the beneficiary of any public or private trust or insurance policy created for such purpose. Grants the board authority of deaccession with respect to any collection of the museum and in case of such deaccessions exempts the board from <u>present law</u> relative to sale or disposal of surplus property. Requires board policies and procedures to carry out such authority.

<u>Proposed law</u> provides relative to unclaimed property loaned to or otherwise left with the museum. Provides that such property shall become property of the museum after 10 years and after notice according to specified procedures. Provides relative to loans of museum property. Provides that museum collections shall be available for use in educational projects subject to board approval.

Effective upon signature of governor or lapse of time for gubernatorial action.

(Adds R.S. 25:380.41-380.45 and R.S. 36:209(C)(5))

Summary of Amendments Adopted by House

- The Committee Amendments Proposed by <u>House Committee on Municipal, Parochial</u> <u>and Cultural Affairs</u> to the <u>original</u> bill:
- 1. Provide that members serve four-year staggered terms rather than terms concurrent with the lt. governor.

- 2. Change the relationship between the museum's board and the Dept. of Culture, Recreation and Tourism.
- 3. Provide for an emergency effective date.

The House Floor Amendments to the engrossed bill:

- 1. Add two members to the board of directors, the speaker of the House of Representatives and the president of the Senate or their designees.
- 2. Remove advising the lt. governor as a duty of the board.
- 3. Specify that the board is created as a body corporate and grant the board powers typical of a corporate body.
- 4. Relative to requests for state funds for the museum, authorize, <u>rather than</u> require, the department to include such requests in its annual budget request.
- 5. Relative to solicitation and acceptance of donations, authorize the board individually or in cooperation with a nonprofit corporation to take such actions rather than the department and any nonprofit corporation, acting jointly or separately.
