2 On page 1, line 2, change "Title 51" to "Title 45"

3 AMENDMENT NO. 2

4 On page 1, delete lines 3 through 5, and insert the following:

5 "comprised of R.S. 45:1621 through 1623, relative to electric vehicle charging  
6 equipment networks; to provide for legislative intent; to provide terms; to provide  
7 for an effective date;"

8 AMENDMENT NO. 3

9 On page 1, line 8, change "Title 51" to "Title 45"

10 AMENDMENT NO. 4

11 On page 1, delete line 9, and insert "comprised of R.S. 45:1621 through 1623, is hereby

2 On page 2, line 6, after "investment" insert "opportunities in charging infrastructure"

3 AMENDMENT NO. 13

4 On page 2, delete lines 8 through 17 and insert the following:

5 "(3) Urging the Louisiana Public Service Commission to explore  
6 excluding persons or corporations from the definition of public utility when all  
7 of the following occur:

8 (a) Those persons or corporations purchase electricity from an electric  
9 public utility or a municipal electric utility.

10 (b) Those persons or corporations furnish electricity exclusively to  
11 charge battery electric vehicles and plug-in hybrid electric vehicles to or for the  
12 public for compensation.

13 (c) Those persons or corporations do not otherwise operate as a public  
14 utility."

18 On page 2, line 21, after "means the" and before "Public" insert "Louisiana"

19 AMENDMENT NO. 16

21 "(2) "Electric public utility" for the purposes of sale for resale of power  
22 related to electric vehicles, or other activities related to operators of electric  
23 vehicle equipment, shall be determined by the commission pursuant to its order  
24 issued in Docket R-36131."
