SCHOOLS/FOOD PROGRAMS: Creates the Lifestyle Choices pilot program

1	AN ACT
2	To enact R.S. 17:195.2, relative to school nutrition programs; to create a pilot program to
3	be implemented in certain schools; to require the State Board of Elementary and
4	Secondary Education and the Department of Agriculture and Forestry to collaborate
5	relative to the pilot program; requires the state Department of Education to
6	administer the pilot program; and to provide for related matters.
7	Be it enacted by the Legislature of Louisiana:
8	Section 1. R.S. 17:195.2 is hereby enacted to read as follows:
9	<u>§195.2. Lifestyle Choices pilot program</u>
10	A. The legislature finds that:
11	(1) Children can make more healthy choices with increased access to fresh,
12	unprocessed produce; whole, healthy grains; and lean sources of protein that all
13	contribute to a balanced diet.
14	(2) Offering healthier options to children is one way to get students involved
15	in nutrition.
16	(3) Some students do not get well-rounded meals at home, which makes the
17	food they eat at school even more significant.
18	(4) School lunches should be composed of more health-conscious food and
19	less processed food.

1	(5) Louisiana students need a base of healthy eating habits that include		
2	eating lean meats, fish, fresh produce, and dairy and an understanding of the food		
3	pyramid.		
4	B.(1) The State Board of Elementary and Secondary Education, in		
5	collaboration with the Department of Agriculture and Forestry, shall develop and		
6	implement a program whereby fresh food is incorporated into school-provided		
7	lunches at certain schools. The state Department of Education shall administer the		
8	program, the purpose of which is assisting school and school food service personnel		
9	to identify and utilize all available resources to increase the variety of healthy food		
10	options in school nutrition programs.		
11	(2) The Department of Education shall identify and select public school		
12	governing authorities for operation of a pilot program as defined by this Section.		
13	(3) The Department of Education and the Department of Agriculture and		
14	Forestry shall collaboratively:		
15	(a) Provide an inventory of food distribution companies with which public		
16	schools or school districts may contract.		
17	(b) Disseminate procurement guidelines, school food safety information, and		
18	liability insurance requirements to food distribution companies that can potentially		
19	contract with schools and school districts for the implementation of the pilot		
20	program.		
21	(c) Consult with the Louisiana State University Agricultural Center, the		
22	Southern University Agricultural Center, the Louisiana Farm to School Alliance, and		
23	other stakeholders, as necessary.		
24	C. Implementation of the provisions of this Section is subject to the		
25	appropriation of funds by the legislature.

Abstract: Creates the Lifestyle Choices pilot program.

<u>Proposed law</u> requires the State Bd. of Elementary and Secondary Education, in collaboration with the Dept. of Agriculture and Forestry (LDAF), to develop and implement a school lunch pilot program to be administered by the state Dept. of Education (DOE).

Provides that the purpose of the program is assisting school and school food service personnel to identify and utilize all available resources to increase the use of more fresh food in school nutrition programs.

Requires DOE to select school governing authorities for participation in the program.

Requires DOE and the LDAF to collaboratively:

- (1) Provide an inventory of food distribution companies to the schools and school districts eligible for participation.
- (2) Disseminate specific procurement guidelines for farmers regarding contracting with schools and school districts and school food safety and liability insurance requirements.
- (3) Consult with university agricultural centers, the La. Farm to School Alliance, and other stakeholders in implementing proposed law.

Provides that implementation of the Lifestyle Choices pilot program is subject to the appropriation of funds by the legislature.
