Amendments proposed by Representative Beaulieu to Engrossed House Bill No. 884 by Representative Beaulieu

1 AMENDMENT NO. 1

2 On page 1, delete line 20 in its entirety and insert in lieu thereof "equal the lesser of the
3 following amounts plus an amount equal to that amount times the growth factor, if the
4 growth factor is positive:"

5 AMENDMENT NO. 2

6 On page 2, line 1, after "(a)" delete the remainder of the line in its entirety and delete lines
7 2 through 10 in their entirety and insert the following in lieu thereof:

8 "The aggregate of the following amounts:
9 (i) The sum of the total amounts appropriated by act of the legislature from
10 the state general fund and dedicated funds as of July first for the fiscal year in which
11 the calculation is made, less amounts appropriated from the state general fund and
12 dedicated funds that were vetoed by the governor and not overridden by the
13 legislature. ~~the expenditure limit for the current fiscal year plus an amount equal to~~
14 that limit times the growth factor if the growth factor is positive.
15 (ii) The total amount of the following for the fiscal year in which the
16 calculation is made:
17 (aa) Amounts expended from state highway fund No. 2, established pursuant
18 to R.S. 47:481.
19 (bb) Amounts expended by the Interim Emergency Board.
20 (cc) Amounts required pursuant to Article VII, Section 26 of the Constitution
21 of Louisiana.
22 (dd) Amounts required for general obligation bond debt service pursuant to
23 Article VII, Section 9(B).
24 (iii) Each expenditure of funds from an appropriation for a prior fiscal year
25 made by legislative act which appropriation has been carried forward into the current
26 fiscal year, to the extent not excluded pursuant to the provisions of Paragraph (C)(1)
27 of this Section.
28 (b) The limit for the fiscal year in which the calculation is made established
29 by the legislature pursuant to"

30 AMENDMENT NO. 3

31 On page 2, delete lines 22 through 24 in their entirety and insert the following in lieu thereof:

32 "(a) The total amount of the following for the fiscal year in which the
33 calculation is made:
34 (i) Amounts expended from state highway fund No. 2, established pursuant
35 to R.S. 47:481.
36 (ii) Amounts expended by the Interim Emergency Board.
37 (iii) Amounts required pursuant to Article VII, Section 26 of the Constitution
38 of Louisiana.
39 (iv) Amounts required for general obligation bond debt service pursuant to
40 Article VII, Section 9(B)."

1 AMENDMENT NO. 4

2 On page 3, after line 3, insert the following:

3 "Section 2. Notwithstanding any provision of law to the contrary, the Joint
4 Legislative Committee on the Budget shall meet no later than October 2022, to determine
5 the state general fund and dedicated funds, as defined in R.S. 39:33.1(D), that do not count
6 towards the calculation of the expenditure limit and towards the calculation of expenditures
7 in relation to the expenditure limit, as provided in this Act."
