A CONCURRENT RESOLUTION

2	To designate Wednesday, May 11, 2022, as Hospital Day at the legislature.
3	WHEREAS, Hospital Day is a day of celebration that serves as a reminder that
4	hospitals in Louisiana are cornerstones of their communities and that hospitals serve people
5	from all walks of life; and
6	WHEREAS, Hospital Day celebrates hospitals and the frontline caregivers who
7	support the health of their communities through their dedication and compassionate care; and
8	WHEREAS, in 2022, the theme of Hospital Day is "We Are Healthcare"; and
9	WHEREAS, through acute care and speciality hospital services, hospitals and health
10	systems in Louisiana play an integral role in providing vital healthcare services to all
11	residents of Louisiana, twenty-four hours a day, seven days a week, three hundred sixty-five
12	days a year; and
13	WHEREAS, today, hospitals are multi-dimensional environments that offer every
14	medical speciality and focus on population health and wellness; and
15	WHEREAS, in addition to providing critical healthcare services, Louisiana hospitals
16	and health systems are economic engines in the state; and
17	WHEREAS, hospitals directly employ more than 102,000 people with an annual
18	payroll of more than \$5.8 billion and contribute more than \$34.7 billion to the state economy
19	through the creation and support of more than 306,000 additional jobs in industries such as
20	construction and retail; and

1 WHEREAS, whether in urban or rural communities, Louisiana hospitals and health 2 systems proactively work to improve health outcomes, quality of care, safety, and 3 satisfaction of their patients and communities; and 4 WHEREAS, Louisiana hospitals and health systems provide comprehensive care for 5 every medical need at every stage of life.
