Amendments proposed by House Committee on Appropriations to Reengrossed Senate Bill No. 490 by Senator Cortez

1 AMENDMENT NO. 1

2 In House Committee Amendment No. 6 in the set of amendments by the Committee on  
3 House and Governmental Affairs (#4142), on page 1, at the beginning of line 18, before  
4 "**legislative**" insert "**the**"

5 AMENDMENT NO. 2

6 In House Committee Amendment No. 9 in the set of amendments by the Committee on  
7 House and Governmental Affairs (#4142), on page 1, at the beginning of line 29, before  
8 "**legislative**" insert "**the**"

9 AMENDMENT NO. 3

10 In House Committee Amendment No. 10 in the set of amendments by the Committee on  
11 House and Governmental Affairs (#4142), on page 2, at the beginning of line 5, before  
12 "**legislative**" insert "**the**"

13 AMENDMENT NO. 4

14 On page 5, delete lines 11 through 18, and insert the following:

15 **"C.(1) Appointments to the council shall be made no later than**  
16 **twenty days after the adjournment of the organizational session of the**  
17 **legislature.**

18 **(2) Any vacancy in the appointed membership of the council shall**  
19 **be filled in the manner of original appointment for the remainder of the**  
20 **term.**

21 **D. The positions of chairman and vice chairman of the council**  
22 **shall rotate in even-numbered years between the members of the House**  
23 **of Representatives and the members of the Senate who serve on the**  
24 **council as provided in this Section. In January of each even-number**  
25 **year, the speaker of the House of Representatives shall designate a**  
26 **member of the House of Representatives on the council who shall serve**  
27 **as chairman or vice chairman of the council, as applicable, and the**  
28 **president of the Senate shall designate the member of the Senate on the**  
29 **council who shall serve as chairman or vice chairman of the council, as**  
30 **applicable."**

31 AMENDMENT NO. 5

32 In House Committee Amendment No. 15 in the set of amendments by the Committee on  
33 House and Governmental Affairs (#4142), on page 2, at the end of line 40, after "Act."  
34 insert the following:

35 "A member of the Capitol Security Council designated by the president of  
36 the Senate shall serve as the first chairman of the council and a member of  
37 the council designated by the speaker of the House of Representatives shall  
38 serve as the first vice chairman of the council. Thereafter, the positions of  
39 chairman and vice chairman of the council shall rotate at the time and in the  
40 manner provided by Section 1 of this Act. The chairman shall call the first  
41 meeting of the council in accordance with this Section."
