20 AMENDMENT NO. 29

21 On page 13, delete lines 13 through 17 and insert the following:

22 "conducted under the pari-mutuel form of wagering that are accepted
23 by an offtrack wagering facility licensee as defined in R.S. 4:211 in
24 accordance with the provisions of Chapter 4 of Title 4 of the Louisiana
25 Revised Statutes of 1950, and a board and Louisiana State Racing
26 Commission approved agreement between the licensee and the offtrack
27 wagering facility licensee or a board and Louisiana State Racing
28 Commission approved plan of operation."

29 AMENDMENT NO. 30

30 On page 13, deletes line 21 through 25, and insert the following:

31 "H.(1) A sports wagering licensee and its retail sports wagering
32 operator may contract with an offtrack wagering facility licensee as
33 defined in R.S. 4:211 to conduct racehorse wagering in its sports book
34 lounge if the terms of the agreement have been approved by the board
35 and the Louisiana State Racing Commission as required by R.S.
36 4:213(B) and the pari-mutuel wagering is conducted in accordance with
37 the agreement."

38 AMENDMENT NO. 31

39 On page 13, delete line 26, and insert "(2) A sports wagering licensee that is an
40 association as defined in R.S. 4:143 and is also the holder of a license "

6 On page 14, at the beginning of line 1, delete "provided" and insert "required"

7 AMENDMENT NO. 34

8 On page 14, between lines 1 and 2, insert the following:

9 **"(3) The board may reconsider and withdraw its approval of an**
10 **agreement or plan of operation upon a finding of noncompliance with**
11 **the terms of the agreement or plan."**
