1 AMENDMENT NO. 1

2 On page 1, at the beginning of line 7, insert "for terms, conditions, and exceptions; to 3 provide"

4 AMENDMENT NO. 2

5 On page 2, line 27, after "<u>Resources</u>" delete "<u>and</u>" and insert "<u>except the secretary may</u> 6 accept any financial security provided to the landowner or lessor for facilities exempted from

permit fees pursuant to Paragraph (D)(3) of this Section. Any bond or other instrument."

8 AMENDMENT NO. 3

9 On page 3, delete lines 20 through 28, and page 4, delete lines 1 through 5, and insert the 10 following:

- 11 "(c) Subparagraphs (a) and (b) of this Paragraph shall not apply to the 12 following solar power generation facilities that are owned by an electric utility 13 provider regulated by the Public Service Commission or the council of the city of 14 New Orleans: 15 (i) Facilities located on land owned by the electric utility provider and the provider is capable of demonstrating a decommissioning plan to the regulator. 16 17 (ii) Facilities located on land leased by the electric utility provider and that 18 meet both of the following conditions: 19 (aa) The regulated electric utility provider guarantees to the landowner or 20 lessor that the regulated electric utility provider will pay the cost of the 21 decommissioning plan provided for in Paragraph (D)(2) of this Section and the 22 guarantee is acceptable to the secretary. 23 (bb) The lease between the landowner or lessor and the regulated electric utility provider provides for site decommissioning at the end of the facility's life, at 24
- the termination of the lease, as determined by a court of competent jurisdiction, and
 upon other circumstance that requires closure of the facility."

On page 4, line 21, after "Section." insert "A permit issued pursuant to this Subsection shall
only pertain to the implementation of the decommissioning plan as provided in Paragraph
(2) of this Subsection, and financial security required pursuant to Paragraph (A)(9) of this
Section."

- 33 On page 5, delete line 14 through 22, and insert:
- 34 "(3) Any solar power generation facility that is certified by the Public Service
 35 Commission or the council of the city of New Orleans on or before August 2, 2022,
 36 shall be exempt from the fees provided for in this Section, shall register with the
 37 department by January 1, 2023, and comply with the requirements of this Section
 38 and any rule and regulations promulgated pursuant to this Section by June 30, 2024."

5 30:1154(D)(1)(d) as enacted by this Act.

6 Section 3. This Act shall become effective on August 2, 2022; if vetoed by
7 the governor and subsequently approved by the legislature, this Act shall become
8 effective on the day following such approval by the legislature or August 2, 2022,
9 whichever is later."
