TRANSPORTATION DEPT: Urges and requests the Department of Transportation and Development to include the Baton Rouge Metropolitan Airport in the passenger rail system between Baton Rouge to New Orleans

1	A RESOLUTION
2	To urge and request the Department of Transportation and Development to include the
3	Baton Rouge Metropolitan Airport in the passenger rail system between New
4	Orleans and Baton Rouge.
5	WHEREAS, the Louisiana Super Region encompasses New Orleans, Baton Rouge,
6	the Bayou Region and surrounding areas, and contains over sixty-five percent of Louisiana's
7	population and over sixty-eight percent of all jobs in Louisiana; and
8	WHEREAS, the Southern Rail Commission's priority projects include the Baton
9	Rouge to New Orleans passenger rail system, which would serve to connect the major
10	population and support economic growth for the Louisiana Super Region; and
11	WHEREAS, the Baton Rouge to New Orleans passenger rail is projected to take trips
12	twice a day with stops in Baton Rouge, Gonzales, LaPlace, the Louis Armstrong New
13	Orleans International Airport, and the New Orleans Union Passenger Terminal next to the
14	Superdome in downtown New Orleans; and
15	WHEREAS, the passenger rail service would provide an alternative to automobile
16	transportation to better connect two of the largest Metropolitan areas in Louisiana; and
17	WHEREAS, the passenger rail service from Baton Rouge to New Orleans is intended
18	to serve the major population; however, the route does not encompass the Baton Rouge
19	Metropolitan Airport; and

WHEREAS, the Baton Rouge Metropolitan Airport's economic impact is over one
billion dollars and it provides approximately four thousand five hundred jobs; and
WHEREAS, including the Baton Rouge Metropolitan Airport in the Baton Rouge
to New Orleans passenger rail would support economic growth and provide alternate
transportation route for workers, tourists, travelers, and citizens in the greater Baton Rouge
area.
THEREFORE, BE IT RESOLVED that the House of Representatives of the
Legislature of Louisiana does hereby urge and request the Department of Transportation and
Development to include the Baton Rouge Metropolitan Airport in the passenger rail system
between New Orleans and Baton Rouge.
