1 AN ACT 2 To amend and reenact R.S. 13:5554(S)(1)(introductory paragraph) and (2), relative to the 3 Franklin Parish Sheriff's Office; to provide for insurance premium payments for 4 sheriff and deputy sheriff retirees; to provide for life insurance; to provide for 5 applicability; and to provide for related matters. Be it enacted by the Legislature of Louisiana: 6 7 Section 1. R.S. 13:5554(S)(1)(introductory paragraph) and (2) are hereby amended 8 and reenacted to read as follows: 9 §5554. Group insurance; kinds; amounts; subrogation 10 11 S.(1) Notwithstanding the provisions of Subsection D of this Section, one 12 hundred percent of the premium costs of group hospital, surgical, and medical 13 expense insurance and life insurance contracted for under the provisions of this 14 Section shall be paid from the sheriff's general fund for any sheriff or deputy sheriff 15 who has retired from the Franklin Parish Sheriff's Office and who is eligible to 16 receive benefits from the Sheriff's Pension and Relief Fund, and who meets either 17 one of the following conditions: * 18 * 19 (2) Notwithstanding the provisions of Paragraph (1) of this Subsection, for 20 any sheriff or deputy sheriff who retires on or after December 31, 2012, and who is 21 eligible to receive benefits from the Sheriff's Pension and Relief Fund, the premium

2	shall be paid from the sheriff's general fund as follows:
3	(a) One hundred percent if the sheriff or deputy sheriff has completed thirty
4	years of full-time continuous creditable service and has completed a majority of his
5	creditable service time with the Franklin Parish Sheriff's Office, regardless of age.
6	A sheriff or deputy sheriff's creditable days of full-time service shall be determined
7	by the Louisiana Sheriff's Pension and Relief Fund.
8	(b) Seventy-five percent if the sheriff or deputy sheriff has attained the age
9	of fifty-five years with at least twenty-seven years of full-time creditable service and
10	has completed a majority of his creditable service time with the Franklin Parish
11	Sheriff's Office. A sheriff or deputy sheriff's creditable days of full-time service
12	shall be determined by the Louisiana Sheriff's Pension and Relief Fund.
13	(c) Fifty percent if the sheriff or deputy sheriff has attained the age of fifty-
14	five years with at least twenty-three years of full-time creditable service and has
15	completed a majority of his creditable service time with the Franklin Parish Sheriff's
16	Office. A sheriff or deputy sheriff's creditable days of full-time service shall be
17	determined by the Louisiana Sheriff's Pension and Relief Fund.
