14 can reduce flood risk and reduce flood insurance premiums."

15 AMENDMENT NO. 15

16 On page 9, after line 17, insert the following:

17 "Section 3. This Act shall become effective upon signature by the governor
18 or, if not signed by the governor, upon expiration of the time for bills to become law
19 without signature by the governor, as provided by Article III, Section 18 of the
20 Constitution of Louisiana. If vetoed by the governor and subsequently approved by
21 the legislature, this Act shall become effective on the day following such approval."
