EXPENDITURE EXPLANATION

There is no anticipated direct material effect on governmental expenditures as a result of this measure. Proposed law creates three separate accounts within the Disability Services Fund and clarifies the approved uses of the money within each account. The approved uses have not changed.

Note: As of March 2022, the fund balance is \$4.3 M. This fund has not been appropriated for the past 3 fiscal years. Deposits into this account result from the sale or lease of all or part of any movable and immovable property previously operated by the Office for Citizens with Developmental Disabilities within LDH, taxes levied on sports wagering, and proceeds from medical marijuana fees, permits, and taxes.

REVENUE EXPLANATION

There is no anticipated direct material effect on governmental revenues as a result of this measure.
