HOUSE FLOOR AMENDMENTS

2022 Regular Session

Amendments proposed by Representative Pressly to Engrossed Senate Bill No. 31 by Senator Fred Mills

1 AMENDMENT NO. 1

2 On page 1, line 2, delete "To repeal" and insert "To enact Part VII of Subchapter A of
3 Chapter 5-F of Title 40 of the Louisiana Revised Statutes of 1950, to be comprised of R.S.
4 40:1273.1 and to repeal"

5 AMENDMENT NO. 2

6 On page 3, line 3, after "health care;" and before "to repeal" insert "to provide relative to the
7 COVID-19 vaccine; to provide for the prohibition of state and local vaccination mandates;
8 to provide for exceptions;"

9 AMENDMENT NO. 3

10 On page 3, between lines 5 and 6, insert the following:

11 "Section 1. Part VII of Subchapter A of Chapter 5-F of Title 40 of the
12 Louisiana Revised Statutes of 1950, comprised of R.S. 40:1273.1, is hereby enacted
13 to read as follows:

14 **PART VII. COVID-19 VACCINATION MANDATES**

15 **§1273.1. Prohibition of COVID-19 vaccination mandates**

16 **A. No state agency, political subdivision, parish, municipality, or other**
17 **local governmental subdivision shall be allowed to issue or enforce any mandate**
18 **requiring proof of a COVID-19 vaccination as a condition for entry into any**
19 **public or private entity, nor shall any such agency or political or local**
20 **governmental subdivision be allowed to issue or enforce any mandate requiring**
21 **proof of a COVID-19 vaccination as a condition to receive goods or services of**
22 **any kind from any public or private entity in its respective jurisdiction. Any**
23 **mandate adopted in contravention of this Part shall be considered contrary to**
24 **the public policy of this state and shall be void and without effect.**

25 **B. The provisions of this Part shall not apply to any COVID-19**
26 **vaccination mandate that is required in accordance with federal law or**
27 **regulation.**

28 **C. Nothing in this Part shall be interpreted or construed to prohibit or**
29 **otherwise impede the rights of a private business or other private entity wishing**
30 **to implement any policy, procedure, or requirement regarding COVID-19**
31 **vaccinations.**
