INSURANCE/AUTOMOBILE: Urges and requests the Department of Insurance to study and make recommendations regarding the effect of dashboard camera installation incentives on automobile insurance rates

A RESOLUTION

2	To urge and request the Department of Insurance to study and make recommendations to the
3	House of Representatives of the Legislature of Louisiana regarding the effect of
4	dashboard camera installation incentives on automobile insurance rates and to report
5	its findings and recommendations.
6	WHEREAS, Kelley Blue Book reported in January 2022 that Louisiana is the state
7	with the fourth highest average monthly cost for car insurance in the United States; and
8	WHEREAS, costs associated with insurance fraud play a pivotal role in the
9	calculation of automobile insurance rates; and
10	WHEREAS, costs associated with litigation play a pivotal role in the calculation of
11	automobile insurance rates; and
12	WHEREAS, video recordings are an admissible form of evidence that can
13	objectively verify or rebut witness testimony; and
14	WHEREAS, a verified timeline of events and a verified cause of damage may
15	minimize the cost of litigating an insurance claim; and
16	WHEREAS, an increased likelihood of being recorded on video may deter bad actors
17	from attempting to engage in fraudulent behavior; and
18	WHEREAS, advances in recording technology have increased the quality of video
19	recordings while decreasing the costs of dashboard cameras; and

1 WHEREAS, an automobile insurance discount for vehicles equipped with dashboard 2 cameras may increase the number of vehicles equipped with such cameras; and 3 WHEREAS, savings from decreased litigation expenses and fewer fraudulent 4 insurance claims may be passed down to policyholders in the form of lower insurance rates; 5 and 6 WHEREAS, it is the duty of the Department of Insurance to study and regulate the 7 insurance industry for the state of Louisiana. 8 THEREFORE, BE IT RESOLVED that the House of Representatives of the 9 Legislature of Louisiana does hereby urge and request the Department of Insurance to study and make recommendations to the Louisiana Legislature regarding the effect of dashboard 10 11 camera installation incentives on automobile insurance rates. 12 BE IT FURTHER RESOLVED that the Department of Insurance shall report its 13 findings and recommendations in writing to the elected members of the House of 14 Representatives of the Legislature of Louisiana and the David R. Poynter Legislative 15 Research Library on or before January 1, 2023. 16 BE IT FURTHER RESOLVED that a copy of this Resolution be transmitted to the 17 commissioner of insurance.
