INSURANCE/AUTOMOBILE: Urges and requests the Department of Insurance to study and make recommendations regarding the effect of excluding advertising expenses in setting automobile insurance rates

2	To urge and request the Department of Insurance to study and make recommendations to the
3	House of Representatives of the Legislature of Louisiana regarding the effect of
4	excluding advertising expenses in setting automobile insurance rates and to report
5	its findings and recommendations.
6	WHEREAS, Statista reported that certain insurance companies spent over one billion
7	dollars in advertising in 2020; and
8	WHEREAS, insurance company mascots have become ubiquitous in cable network
9	commercials, internet advertisements, and video streaming commercials; and
10	WHEREAS, the insurance market is an industry concerned with mitigating the cost
11	of losses by spreading risk among policyholders; and
12	WHEREAS, policyholders pay premiums to insurance companies for the purpose of
13	receiving insurance proceeds in the event of a loss to assist them in financing repairs of the
14	damage resulting from a loss; and
15	WHEREAS, policyholders do not pay premiums to insurance companies for the
16	purpose of being entertained during commercial breaks in television programing; and
17	WHEREAS, it is in the interest of the residents of Louisiana to pay reasonable
18	insurance premiums for adequate coverage; and
19	WHEREAS, Kelley Blue Book reported in January 2022 that Louisiana is the state
20	with the fourth highest average monthly cost for car insurance in the United States; and

THEREFORE, BE IT RESOLVED that the House of Representatives of the

WHEREAS, it is the duty of the Department of Insurance to study and regulate the insurance industry for the state of Louisiana.
