8	Be it enacted by the Legislature of Louisiana:
9	Section 1. R.S. 36:259(B)(34) is hereby amended and reenacted to read as follows:
10	§259. Transfer of agencies and functions to Louisiana Department of Health

12	B. The following agencies, as defined in R.S. 36:3, are placed within the
13	Louisiana Department of Health and shall perform and exercise their powers, duties,
14	functions, and responsibilities as otherwise provided by law:

19	Section 2. R.S. 40:2018.1(A), (B)(1)(i), (C), and (E) are hereby amended and
20	reenacted to read as follows:
21	§2018.1. Louisiana Commission on HIV, AIDS, and Hepatitis C Education,
22	Prevention, and Treatment
23	A. The legislature hereby establishes within the office of public health of the
24	Louisiana Department of Health a commission which shall be designated the

2	Treatment". The commission shall be composed of thirty-three members as provided
3	in Subsection B of this Section.
4	B.(1) Twenty members shall serve at the governor's pleasure and shall be
5	appointed by the governor as follows:
6	* * *
7	(i) Three representatives from the Louisiana Department of Health who have
8	knowledge of policies related to HIV, AIDS, and hepatitis C and who work in the
9	office of public health, office of behavioral health, and bureau of health services
10	financing, respectively.
11	* * *
12	C. The chairman of the commission shall be appointed by the governor and
13	The commission, in open session, shall elect from among its members a chairman,
14	who shall serve as chairman without salary.
15	* * *
16	E. The functions of the commission shall be to:
17	(1) Serve as an advisory body to the governor and the Louisiana Department
18	of Health on matters relating to hepatitis C , HIV, and AIDS and HIV.
19	(2) Serve as a coordinating forum on matters relating to hepatitis C , HIV,
20	and AIDS and HIV between and among state agencies, local government, and
21	nongovernmental groups.
22	(3) Research and review all state regulations, guidelines, policies, and
23	procedures relative to prevention, treatment, and care of hepatitis C, and HIV
24	infection, and AIDS and, when appropriate, make recommendations to the governor,
25	the secretary of the Louisiana Department of Health, and the legislature.
26	(4) Provide a forum for an annual public hearing on matters relating to
27	hepatitis C , HIV, and AIDS and HIV as well as a mechanism for other public
28	comments and peer reviews on federal and state-funded programs related to hepatitis
29	C , HIV, and AIDS and HIV.
