HOUSE BILL NO. 770

1	AN ACT
2	To enact Chapter 23 of Title 25 of the Louisiana Revised Statutes of 1950, to be comprised
3	of R.S. 25:1011 through 1016, and R.S.36:4(S), relative to boards and commissions;
4	to establish the Louisiana Governor's Mansion Commission; to provide for the
5	membership and powers, duties, and functions of the commission; to authorize the
6	commission to establish advisory committees; and to provide for related matters.
7	Be it enacted by the Legislature of Louisiana:
8	Section 1. Chapter 23 of Title 25 of the Louisiana Revised Statutes of 1950, to be
9	comprised of R.S. 25:1011 through 1016, is hereby enacted to read as follows:
10	CHAPTER 23. LOUISIANA GOVERNOR'S MANSION COMMISSION
11	§1011. Establishment; purpose
12	The Louisiana Governor's Mansion Commission, hereafter in this Chapter
13	referred to as the commission, is hereby created and established as an agency in the
14	office of the governor, for purposes of protection and enhancement of the governor's
15	mansion, its contents, furnishings, and grounds. The purpose of the commission is
16	to ensure a continuum in the appearance, the preservation of contents, furnishings,
17	and surrounding areas of the governor's mansion consistent with the historical
18	significance and importance of the governor's mansion.
19	§1012. Jurisdictional area
20	The commission shall have jurisdiction over the public as well as private
21	areas of the governor's mansion and grounds. Public areas shall consist of the first
22	floor, the stairwell in the rotunda, the state wing of the second floor, and all grounds

1	in front and on each side of the mansion. The private areas of the governor's
2	mansion and grounds shall be all other areas within the mansion and grounds not
3	specifically described as a public area in this Section.
4	§1013. Membership; appointment; terms; officers; compensation
5	A. The commission shall be composed as follows:
6	(1)(a) If the governor is married, the governor's spouse or the spouse's
7	designee.
8	(b) If the governor is unmarried, the governor or his designee.
9	(2) A person appointed by the person serving on the commission pursuant
10	to Paragraph (1) of this Subsection.
11	(3) The person employed at the governor's mansion in the position known
12	as the executive residence director.
13	(4) A member of a former governor's family appointed by the governor.
14	(5) Three members appointed by the governor after consultation with staff
15	employed at the governor's mansion.
16	B.(1) The initial terms of the members appointed pursuant to Paragraphs
17	(A)(2), (4), and (5) of this Section shall be as determined by lot at the first meeting
18	of the commission as follows: one member shall serve an initial term of one year;
19	one member shall serve an initial term of two years; one member shall serve an
20	initial term of three years; one member shall serve an initial term of four years; and
21	one member shall serve an initial term of five years.
22	(2) After the initial term of office, the term of each of the members
23	appointed pursuant to Paragraph (A)(2), (4), and (5) of this Section shall be five
24	years.
25	C.(1) The person serving on the commission pursuant to Paragraph (A)(1)
26	of this Section shall serve as the chairman of the commission, and the members of
27	commission may provide for other officers of the commission as deemed necessary.

1	(2) The commission may create an executive committee from among its
2	membership to ensure the prompt and efficient conduct of the powers, duties, and
3	functions of the commission.
4	(3) The commission may establish and provide for advisory committees to
5	advise and assist the commission in the performance of its duties.
6	D. Members of the commission shall serve without compensation, but may
7	receive reimbursement for expenses directly related to service on the commission in
8	accordance with law.
9	§1014. Commission powers, duties, and responsibilities; approval of changes
10	<u>required</u>
11	A. No improvement, renovation, redecoration, or enhancement of the public
12	or private areas and grounds of the governor's mansion shall be made without the
13	prior approval of the commission. Commission approval shall be required prior to
14	any painting, renovation, non-appliance repair, redecoration, or significant
15	movement of or rearrangement of furniture, artwork, antique pieces, vases, or other
16	items in the public areas.
17	B. In addition, the commission shall have the following powers, duties,
18	functions, and responsibilities:
19	(1) To promote a greater understanding and awareness of the importance and
20	significance of the governor's mansion and enhance and maintain the appearance,
21	furnishings, and surroundings thereof so that it may serve as a symbol and actual
22	representation of the history and cultural heritage of the state.
23	(2) To assist in research for and promote the publication of appropriate
24	materials concerning the governor's mansion and its contents and grounds and the
25	history and significance thereof, and to coordinate and guide any such activity by
26	other state and local agencies.
27	(3)(a) To enter into loan agreements for the loan of any item that is not
28	owned by the state and that is to be housed in the governor's mansion or located on
29	its grounds and for the loan of any item owned or controlled by another state agency
30	which is to be housed in the governor's mansion or located on its grounds.

1	(b) Any item that is subject of a loan agreement shall be included in the
2	property inventory of the governor's mansion as required by R.S. 39:324.
3	(c) Any item that is the subject of a loan agreement shall be covered by
4	adequate insurance through the office of risk management to insure repair or
5	replacement. The commission shall participate in the state's risk management
6	program and provide for such coverage through the program.
7	(4) To create a program for annual audit, spot-check inventory, and post-
8	audit functions for the protection of all items contained in the inventory.
9	(5) To provide a procedure for receiving inventory items at the end of a
10	governor's term and for turning over the inventory items to the incoming governor's
11	spouse or designee.
12	(6) To monitor public and private areas and grounds of the governor's
13	mansion to insure proper maintenance and repair.
14	§1015. Cooperation by other state entities
15	A. The office of state buildings and grounds within the division of
16	administration shall timely perform or provide for all requests for maintenance and
17	repair to the governor's mansion and its grounds made by the commission.
18	B. All departments, commissions, boards, agencies, officers, and institutions
19	of the state and all subdivisions thereof shall cooperate with the commission in
20	carrying out the powers and purposes of this Chapter.
21	§1016. Funding; donations and grants
22	The commission, either directly or through a foundation established to aid the
23	commission in a philanthropic manner, may solicit, accept, use, and dispose of any
24	private or public funds in the form of donations of money, grants, property, or
25	personal services from individuals, corporations, and governments to achieve the
26	purposes of this Chapter subject to rules and regulations adopted by the commission.
