1	A RESOLUTION
2	To commend Bishop Shelton J. Fabre, the fourth bishop of the Diocese of Houma-
3	Thibodaux, on being appointed archbishop of Louisville, Kentucky.
4	WHEREAS, Shelton J. Fabre was born on October 25, 1963, in New Roads,
5	Louisiana; he attended Catholic schools throughout his formative years and graduated as
6	valedictorian from Catholic High School of Point Coupée in 1981; and
7	WHEREAS, Bishop Fabre completed his seminary studies at St. Joseph Seminary
8	College in St. Benedict, Louisiana, and the Katholiek Universiteitte Leuven in Leuven,
9	Belgium, and was ordained a priest on August 5, 1989, by Bishop Stanley J. Ott at St. Joseph
10	Cathedral in Baton Rouge; he also holds a master of arts degree in religious studies; and
11	WHEREAS, as a priest of the Diocese of Baton Rouge, Bishop Fabre's parish work
12	included service as pastor of the parishes of St. Joseph in Grosse Tete and Immaculate Heart
13	of Mary in Maringouin, and parochial vicar at St. George Parish, St. Alphonsus Liguori
14	Parish, and St. Joseph Cathedral; and
15	WHEREAS, Bishop Fabre was appointed auxiliary bishop of the Archdiocese of
16	New Orleans by Pope Benedict XVI and was ordained an auxiliary bishop by Archbishop
17	Alfred C. Hughes at the Cathedral-Basilica of St. Louis, King of France on February 28,
18	2007; and
19	WHEREAS, after serving the Archdiocese of New Orleans for six years, Bishop
20	Fabre was appointed bishop of the Diocese of Houma-Thibodaux; he has served the Houma-
21	Thibodaux community since his installation on October 30, 2013; and

1	WHEREAS, Bishop Fabre has served as chair of the United States Conference of
2	Catholic Bishop's Ad Hoc Committee on Racism since 2018 and has been an active and
3	effective leader of the bishop's anti-racism initiatives; and
4	WHEREAS, Bishop Fabre has once more been called to serve at an even higher
5	clerical post for the Catholic Church; on February 8, 2022, he was named as archbishop-elect
6	of the Archdiocese of Louisville by Pope Francis; he is scheduled to be installed in his new
7	position on March 30, 2022; he is most deserving of the highest recognition for his career
8	of service to the people of Louisiana and for his acceptance of his new role as archbishop
9	of Louisville.
10	THEREFORE, BE IT RESOLVED that the House of Representatives of the
11	Legislature of Louisiana does hereby commend Bishop Shelton J. Fabre, the fourth bishop
12	of the Diocese of Houma-Thibodaux, on being appointed archbishop of Louisville,
13	Kentucky; does hereby further recognize Archbishop Fabre for faithfully serving the state
14	of Louisiana for more than two decades; and does hereby extend sincerest wishes that he
15	continue his amazing work with the most genuine support from his new faith community.
